The first is from the Tennessee Law Review and is titled "*Proposing Constitutional Amendments by Convention: Rules Governing the Process*". The second is from the Florida Law Review and is titled "*Founding-Era Conventions and the Meaning of the Constitution's Convention for Proposing Amendments*". If you take the time to read any of these I assure you that you will know more about this subject than 99.9% of America. I love history and have studied it for many years and I have a Master's degree in Law, but I did not know the history surrounding this subject.

1. Taken from the Tennessee Law Review. Much of the mystery surrounding the Constitution's state-application-and-convention amendment process is unnecessary: History and case law enable us to

resolve most questions. This Article is the first in the legal literature to access the full Founding-Era record on the subject, including the practices of inter-colonial and interstate conventions held during the 1770s and 1780s. Relying on that record, together with post-Founding practices, understandings, and case law, this Article clarifies the rules governing applications and convention calls, and the roles of legislatures and conventions in the process. The goal of the Article is objective exposition rather than advocacy or special pleading.

2. Taken from the Florida Law Review. Under Article V of the U.S. Constitution, two thirds of state legislatures may require Congress to call a "Convention for proposing Amendments." Because this procedure has never been used, commentators frequently debate the composition of the convention and the rules governing the application and convention process. However, the debate has proceeded almost entirely without knowledge of the many multi-colony and multi-state conventions held during the eighteenth century, of which the Constitutional Convention was only one. These conventions were governed by universally-accepted convention practices and protocols. This Article surveys those conventions and shows how their practices and protocols shaped the meaning of Article V.

 (Washington, D.C., April 17, 2014) -- There is a deeply disturbing article in the USA Today that I encourage you to read and share with others. It's linked on my blog. It reports that leaflets are spreading through the eastern Ukrainian city of Donetsk saying that government officials controlled by pro-Russian

forces are ordering Jews to register with local authorities and pay a fee, or they could be deported and their assets could be confiscated.

Secretary of State John Kerry on Thursday called such actions “intolerable” and “grotesque.” But pro-Russian separatists flatly deny the allegations that they have been distributing leaflets requiring Jews to register.

The leaflets exist. They’ve been spread all over Donetsk. They’re printed on official government stationery and they bear the signature of the mayor. But the mayor says he didn’t write it. So who did? Are they a hoax, or official policy?

One thing is clear: someone is targeting the Jewish people of Ukraine, trying to instill fear in them, and trying to get them to leave the country.

“The threat left many of the 15,000 Jews of Donetsk ‘shocked and hysterical,’ the chief rabbi of the city told The Daily Beast in an interview on Thursday.

Given the long history of virulent anti-Semitism in the region, there is reason to be concerned for the safety of the roughly 200,000 Jewish people in Ukraine.

Consider recent headlines:

- Jewish Agency to extend emergency aid to Ukraine’s Jewish community (Ynet News, Feb 23)

- Sharansky: We are quietly saving Jews from Ukraine, Iran (Times of Israel, March 28)
- Ukrainian Jewish Immigration to Israel Rises 70 Percent (Jewish Press, April 7)

As I write about in "The Auschwitz Escape," Adolf Hitler made similar legal moves against the Jewish people in the early 1930s, separating them out from the rest of the population. We know where it led -- the Final Solution and the gas chambers a few years later. We cannot yet say where the leaders of Donetsk are going with this, but clearly such moves bode ill.

Please pray for the Jewish people in Crimea and throughout Ukraine, for safety and protection and for the Lord to truly bless them amidst this crisis and beyond.

### **Family Research Council's: Prayer Targets: Israel, National Day of Prayer**

*Now the LORD... said unto Abram, Get thee out of thy country...unto a land that I will shew thee: And I will make of thee a great nation... And I will bless them that bless thee, and curse him that curseth thee: and in thee shall all families of the earth be blessed. Genesis 12:1-3*

I am writing you from Jerusalem, Israel, where I am participating in a unique leadership program jointly sponsored by [Yad Vashem](#), [The Museum of the Bible](#), and the [International Christian Embassy, Israel](#). The small circle of participants will meet with survivors of the Holocaust, Israeli leaders, and absorb lectures by mature scholars. These advocates are deeply concerned that despite efforts to assure that the world "never forgets" the Holocaust, evidence shows a shocking global [resurgence of anti-Semitism](#), including in the United States.

U.S. negotiations and agreements with Iran, laced with economic aid, have only encouraged Iran to continue its nuclear expansion. In fact, Iranian leaders deny that the Holocaust ever occurred, have repeatedly pledged to destroy Israel, and openly mock the U.S. for its submission to Iran's will. [Designated a terrorist state by the U.S. State Department in 1984](#), Iran is only one of four countries so labeled. Moreover, despite soothing rhetoric,

current American policy and behavior reflects an abandonment of our longtime commitment to our Israeli allies, and exposes Israel (and other moderate Middle East nations) to Iran's hegemony. Those who read FRC's *Prayer Team Targets* or Tony Perkins' *Washington Update* know that while foreign relations may not be among FRC's core policy issues, our friendship with Israel is critically important to us. Without God's blessing upon our nation, there is little hope for the noble goals for which we pray and labor to be achieved. America has been uniquely blessed, partly because of our historic faithfulness to God's covenant people, with whom we share historic and spiritual ties (Gen 12:1-3). However this has been changing rapidly.

In 1991 the U.S. departed from its official policy not to negotiate with terrorists. We began both to engage in such negotiations ourselves and to put pressure on Israel to engage in such negotiations with terrorist Yasser Arafat and the PLO (Fatah), but also to come to terms - terms radically detrimental to Israel (e.g., release of convicted terrorists). Later Hamas (an even more radical terrorist group than Fatah, birthed from the Egyptian Muslim Brotherhood) was elected by the Palestinian people to lead the Palestinian government. Fatah, unwilling to hand over power to the supra-radical group, took charge of the Jordan River's West Bank (immediately north and east of Jerusalem) and let Hamas rule Gaza. Hamas has been behind intermittent rocket barrages against Israeli civilian targets and repeated suicide bombings intended to kill the maximum number of civilians inside Israel. These are the groups that the U.S. is pressuring Israel to come to terms with. Increased hostility toward Israel and support for Palestinian Statehood has been growing, feverishly in some countries.

While God has deemed the Jews as His chosen people, there is no such thing as "Israeli infallibility." The government of Israel is not perfect and has made what some deem as unreasonable concessions due to U.S. pressure. Giving Gaza and the West Bank over to the Palestinians to govern was one of them. Like every nation, Israel has a God-given responsibility to protect its borders and its people. Yet God's covenant people have been given a unique land grant from God himself, and He warns that the nations who trouble Israel and seek to divide up the land will suffer consequences ([Joel 3:1-2](#); [Zech 12:3](#)). Even if God's word allowed for the dividing of the land, Israel would be unwise to consent to deeding their land to disorganized, factious, terrorist regimes. These regimes are dedicated to Israel's destruction and refuse even to recognize Israel's right to exist. Thus Israel now finds the government of its closest friend, the United States -- along with other world powers -- pushing Israel to divide their land, which would reduce Israel's land mass and so reshape Israel as to render it nearly militarily indefensible. Despite America's history of support and friendship with Israel, by its increased pressure on Israel, its concessions and economic aid to nuclear Iran, the U.S. government has become part of the problem. And the world sees it.

Amid the many failures of the Obama Administration, this behavior is near the top of the list. This, like other matters of American government that challenge God's eternal moral laws -- abortion, immoral sexual license, anti-Christian persecution, class and racial warfare, are not just political and policy issues, they are deeply spiritual matters that offend Almighty God and defy His plain commands and natural and moral order. They have to do with good and evil. Our State Department's Office of International Religious Freedom has done little of substance during the Obama Administration to defend either Jews or Christians, except when it has come under such tremendous public pressure it had to do something. And as I have previously reported, Americans, including some Evangelicals, are pulling back from their support for Israel - and Evangelicals have truly been Israel's best friends.

While I am in Jerusalem, Secretary of State John Kerry's deadline for Israel to submit to U.S. pressure will come to an end. Will the Obama administration pull even more support from Israel than it already has, as President Obama suggested before his last meeting with Prime Minister Netanyahu? Not only Israel's but America's destiny will be impacted by that answer. 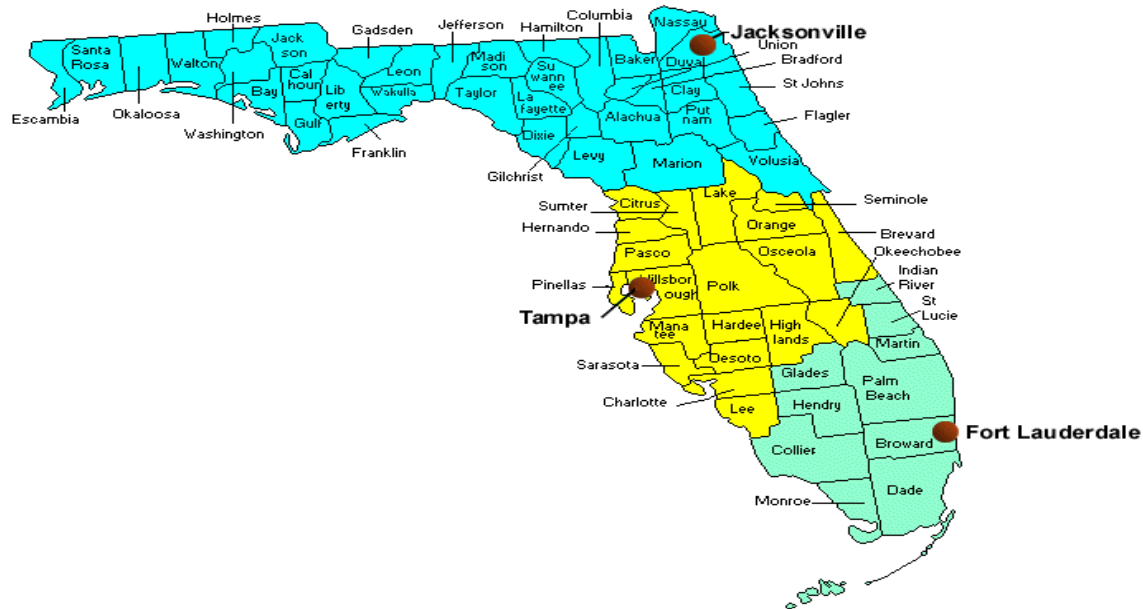

Another Supreme Court Judge, Ruth Bader Ginsberg, suggested that Egypt not look to America's Constitution, but perhaps they would be better served by looking to the Constitution of South Africa.

We are on the verge of securing that our Constitution is the only basis deciding cases in our court rooms. It will put a stop to precedent setting rulings that would undermine the strength of our Constitution.

## Action/Prayer/FYI Item #6:

### Update on the Senate Appropriations Committee Report for property owners' septic systems in the state of Florida

It was an adventure and interesting political theater, yesterday in the Senate Appropriations Committee.

An entirely new bill was introduced for CS/CS/SB 1576. But, before that substitute could be debated, several "late-file" amendments were introduced and adopted "without objection." To the credit of the sponsoring Senators, the amended version has *several improvements*. What are they?

Deleted was the authorization for local governments to establish Responsible Management Entities. Retained was the state statute on septic systems inspections which serves our state well. And, strengthened was the Basin Management Action plan (BMAP) process for assessing and addressing potential pollution sources.

CPR offered testimony in the committee pointing out the bill still mandates *a one-size-fits-all approach to regulating property owners' septic systems*. In fact, in the water quality section of the bill, one third of the language focuses on septic systems. Such mandates could impair the work of the BMAP process which is designed to be spring-shed specific. All potential pollution sources should be considered, not just a focus on one.

CPR, once again, pointed out the need for science-based identification of pollution sources, without which effective remediation cannot take place. However, the Senators have not addressed this in the bill language although they say they want a scientific approach. The bill is approximately 24 pages. And yet, *the word science does not appear once*; neither do the words scientific data or scientific method.

The biggest surprise of the day, however, was reserved for the League of Cities and Association of Counties. One of the amendments removed the promise of recurring funding to carry out the mandates of the bill. Without such funding, they do not wish to be left with unfunded mandates.

Following a close to the bill offered by Senator Simmons, *the Appropriations Committee voted unanimously to pass the bill.*

By way of observation, it is curious that the bill has been heard now in three committees. CPR has not heard one question from a Senator and, not one Senator has asked to be recognized in debate over this bill.

The bill now moves to be considered by the entire Senate. In the Florida House, the bill has yet to be heard in its first committee (the Agriculture and Natural Resource Subcommittee). Without an identical House companion, the Senate bill cannot become law. Please note, even at this late date, the House leadership could call a special meeting of that first committee to hear and pass the bill. It would then be eligible to be withdrawn from its other two committees of reference and be put before the entire House for a vote.

Remain vigilant. CPR will work to keep you informed.

## **Action/Prayer/FYI Item #7:**

**American Laws for American Courts bills are calendared for votes by the full Senate and House. Please take action now!**

[HB 903](#) and [SB 386](#) entitled *Application of Foreign Law in Certain Cases*, commonly known as "[American Laws for American Courts](#)", would prohibit Florida courts from considering certain provisions of foreign laws, including Islamic Sharia law, if such provisions are inconsistent with the Florida and United States of America Constitutions.

If Florida courts accept provisions of Islamic Sharia law or other foreign laws or legal codes which are inconsistent with American laws it will undermine public policies enacted by our representative form of government and change our value system.

**Application of Foreign Law in Certain Cases:** Defines "foreign law, legal code, or system"; specifies public policy on application of foreign law, legal code, or system in proceedings relating to dissolution of marriage, support, time-sharing, UCCJEA, & UIFSA; provides that certain decisions rendered under such laws, codes, or systems are void; provides that certain contracts & contract provisions are void; provides for construction of waiver by natural person of person's fundamental liberties, rights, & privileges guaranteed by state or federal constitutions; provides that claims of forum non conveniens or related claims must be denied; provides that act doesn't require or authorize court to adjudicate, or prohibit any religious organization from adjudicating, ecclesiastical matters in violation of specified constitutional provisions or to conflict with any federal treaty or other international agreement to which U.S. is party to specified extent. [Full text of SB 903.](#)

[HB 903](#) and [SB 386](#) have passed all committees in the Florida House and Florida Senate. The legislation is on the Second Reading calendar in both the House and Senate.

The Florida Senate is the chamber that needs the most urging to pass this legislation on for Governor Rick Scott's signature.

[HB 1047 / SB 918](#) **Bans Abortion of a Viable Fetus** - Rep. Adkins (R) / Sen. Flores (R)

This bill bans abortion if the doctor reasonably determines, in good faith medical judgment, that the child has achieved viability. It provides strict exceptions if the mother's life is endangered by the pregnancy or if the mother will suffer substantial and irreversible physical damage by continuing the pregnancy.

**PASSED the Senate today on April 25, 2014 by a 24-15 vote margin. This is HUGE! This bill is headed to the Governor's desk for his signature!**

**Termination of Pregnancies bans any abortion of a viable fetus. This bill makes Florida's abortion ban as early as possible without violating Roe vs. Wade. By banning abortion of viable fetuses we create a moving target for abortion ban as technology improves to allow for earlier viability.**

[HB 989 / SB 768 Human Trafficking](#) - Rep. Trujillo (R) / Sen. Braynon (D)

This bill broadens the term "sexual abuse of a child" to include human trafficking. This allows victims of human trafficking to be eligible for crime victim compensation awards and financial relocation assistance and other protections and services that sexually abused children receive.
