In addition, someone on Face Book pulled up the The ALS Association's 2013 tax returns to take a closer look at how their funds are spent. Here are the salaries for the leadership of the group:

Jane H. Gilbert – President and CEO – \$339,475.00

Daniel M. Reznikov – Chief Financial Officer – \$201,260.00

Steve Gibson – Chief Public Policy Officer – \$182,862.00] Kimberly Maginnis - Chief of Care Services Officer – \$160,646.00

Lance Slaughter - Chief Chapter Relations and Development Officer – \$152,692.00

Michelle Keegan – Chief Development Officer – \$178,744.00

John Applegate – Association Finance Officer – \$118,726.00

David Moses – Director of Planned Giving – \$112,509.00  
Carrie Munk – Chief Communications and Marketing Officer – \$142,875.00  
Patrick Wildman – Director of Public Policy – \$112,358.00  
Kathi Kromer – Director of State Advocacy – \$110,661.00

Total administration costs, as seen in the pie chart above, were just under \$2 million. “Other salaries and wages” (Part IX line 7) were \$3.6 million, with another half million dollars in “pension plans” and “employee benefits.” Expenses for non-employee labor were about \$4 million, and “travel expenses” exceeded \$1.3 million.  
So total costs for labor to run the association was around \$12.5 million, from revenues received totaling \$24 million.

Over 50% of what the ALS Association receives appears to support salaries of people working for the Association, based on these tax returns.

So what about the rest of the revenue?

Almost \$1 million was spent on “Lobbying” (Schedule C Part II 2a). Here is what they wrote concerning their Lobbying efforts:

Explanation: The purpose of our advocacy program is to sensitize legislators to, and obtain their sympathy for, the plight of ALS victims, patients and their families, and to influence legislation regarding the appropriation of federal funds for ALS research and the use and cost to patients of “orphan” drugs.

The largest amount of what is remaining is: “Grants and other assistance to governments and organizations in the United States” (Part IX line 1) – \$6.2 million. This amount is itemized on Schedule 1. Almost all of these recipients are medical schools, with strong ties to the pharmaceutical industry.

The ALS Association was started in 1985, and they still have not invested in any new cures for ALS. One of the latest failures was Biogen’s drug dexamipexole, which halted research in early 2013. The drug was in research for more than 10 years at an estimated cost of between \$75 million and \$100 million, but was abandoned in last stage development due to poor results. (Source.)

**If You Are Pro-life, You Are Supporting Research in Stem-Cells from Aborted Fetuses for ALS**

The ALS Foundation’s primary work in “research” is in the development of new pharmaceutical drugs, and that includes stem cell research. Here is one study where they have been listed as a sponsor: A Phase I, Open-label, First-in-human Feasibility and Safety Study of Human Spinal Cord derived Neural Stem Cell Transplantation for the Treatment of Amyotrophic Lateral Sclerosis. Quote:

These stem cells have been engineered from the spinal cord of a single fetus electively aborted after eight weeks of gestation. The tissue was obtained with the mother’s consent.

## **Action/Prayer/FYI Item #8:**

You must understand this, because to be His prophet in these times you must be in agreement with Him and His purposes at all times, even when it is time for judgment.”* I highly recommend every Christian get this book and read it.

Therefore, we must not only heed this warning, we must also be in agreement with God’s will to prevail for His eternal purposes for all the nations, including America, to come to fruition so that the final Great Awakening can sweep across America and the rest of the world for the purpose of the “ingathering” of the end-time harvest our souls into the *kingdom of heaven*. Hence, there will be no stopping God’s judgment from commencing for it must take place because God in His love and mercy for His people He cannot and will not leave the corporate *body of Christ* as we currently are.

**Judgment In America** - Neville Johnson

8-8-2014

These are notes from message given in Lancaster, CA. Neville Johnson, Terry Bennett, Sadhu Sundar Selvaraj all received very similar revelation that this October, as we pass the Day of Atonement on October 4th, will be a demarcation point. We will begin to see Rom. 11:22: The GOODNESS and SEVERITY of God.

There is coming an UNPRECEDENTED release of the Holy Spirit that will eventually be SEVEN TIMES what was released on Pentecost. Bro. Sadhu was told, in an angelic visitation, that there is no Biblical reference to what God will release. Terry was told: "This will not be a general release to the body, but to the prepared vessels, to the trained ones, to the shining ones who will be His bride."

In an encounter with the Lord Jesus, He told Terry that this will be true of those prepared vessels who will receive this unprecedented release: Jesus said "I will be love, reason, passion, portion and proclamation."

The greatest harvest of all history will begin to come in. Every kind of conceivable miracle and beyond will begin to happen. The Church will radically change in the way we meet and function.

Ministry will take place inside and also very much outside the church walls. The committed and refined saints will be "re-filled, strengthened, instructed and encouraged" in the Church but go out and release the kingdom in the marketplace, schools and secular arenas with power and signs and wonders. An unprecedented harvest will come in.

This great revival will happen through a REMNANT in the Church. It is not a remnant because of God's choosing; but it is a remnant because of only a limited number of God's people choosing to respond wholeheartedly, in purity of heart and motives and consecration to Him.

All the judgments coming on the USA have been delayed as long as possible. There will be no more delay. All three prophets were told this.

Bro. Sadhu was told in an encounter with Moses: 1) The US has been sinking deeper and deeper into a sinkhole of iniquity. 2) Military force will be used by God to chasten the nation.

The prophets have seen the collapse of the dollar. In a face-to-face encounter with the Lord Jesus: A Military coup ousting O\* in order to try to steer our nation back on the right track. O\* being put on trial for treason. O\* playing the race card, resulting in racial riots (Hispanic, Black, White, all races). The Lord said: It will not go well with O\*. Civil unrest all over the nation will follow. Bob Jones said in 2014 Shepherd's Rod "those leaders who have lied to us will come to an end."

Sadhu was told in a supernatural encounter: "The nation's hypocrisy will be torn apart. O\* will be punished. The W H will burn with fire."

Natural disasters, volcanoes, earthquakes, tsunamis and storms will come. UN troops will be invited here – coming in to try to bring stability, or at least under that guise. However, they will mostly be Russian, and they will be fighting against us on our soil for 2-3 years – heavy fighting in the Northeast US. When Russian troops try to advance to the Southern part of our nation, Terry was told by the Lord in an encounter: "The South will rise up and save your nation." Russia will withdraw because of heavy losses.

God is allowing all these disasters to save our nation rather than utterly destroy us. The USA will be significantly reduced in power (as has already been happening under O's regime).

THE USA has crossed a line. The cup of iniquity is full. The judgments cannot be stopped; but wherever there are houses of prayer, contending for God's mercy and His will to be done, there will be safety, provision and His Presence. An unprecedented harvest will come in to these places of refuge where there are saints who have allowed the Lord to build them together into a holy House of Prayer and habitation of His presence. (Ephesians 2:22).

The USA will eventually have a re-birth of righteousness. When the dust settles, after we have gone through the severe discipline of the Lord, our nation will be re-born with a new, more detailed constitution, and it will be the righteous who will be leading.

Neville said: the culture of heaven is THE FRUIT OF THE SPIRIT. We must become peculiar people, living as citizens of heaven, knowing we are a chosen generation, a holy people, God's own special people given to him for His pleasure and His will. We must be established in the character, love, obedience, humility and purity of the Holy Spirit fruit. That is the culture of heaven.

In an encounter with the Lord Jesus, Terry Bennett was told that GOD IS LOOKING FOR AN ELITE GROUP OF WARRIORS who will completely lay down their lives and stand in the gap in prayer for HIS WILL to be done. The Lord said "They will be fierce and fearless. They will create history. They will FORCE HISTORY TO MY CONCLUSIONS" (the will of God).

Terry said we MUST pursue the things of 2 Peter 1 if we are TO BE FRUITFUL and have access into the kingdom realm. With all Diligence add to your FAITH Virtue, Knowledge, Self Control, Perseverance, Godliness, Brotherly Affection, Christian Love. SO WE MUST FOCUS ON and PURSUE these THINGS in order to BEAR FRUIT and BE APPROVED BY GOD.

Terry was taken to heaven and saw all these words written on the steps going up to the throne of God. At the bottom step was "self-control, and each step had a quality of the fruit of the Spirit.

The House of the Lord MUST BE BUILT (the habitation of God according to Ephesians 2:22). The House of the Lord could only be built after all the "ites" (like Hittites, Amelikites, etc.) were driven out (this represents sin, pride, offense, division, anger, lust, etc). FERVENCY of SPIRIT is our weapon!!!!

Our battle is to HAVE ENOUGH QUIET TIME EACH DAY in the LORD'S PRESENCE and in HIS WORD that our Spirit is FERVENT with the literal fire of His presence. (Moses was on fire by communing with the Lord, Jeremiah was on fire by the Word of God in his bones). In Acts 6, the apostles said we will not get entangled with natural affairs but give ourselves "continually to prayer and the Word."

We must recognize that "the battle" is to get to the battle (of united corporate persevering intercession). The enemy is working to keep us from two things: **1) Personal devotion, Word, prayer time (so that we have little or no anointing or fire)· 2) Corporate intercession and warfare.**

Bro. SADHU asked Moses: What can be done to reduce the severe chastisement coming on the USA? He was told by Moses that the Christians are too self-centered. They will not weep and pray for their nation. But if 2 Chron. 7:14 were obeyed by the leaders in the USA then disasters could be averted.

NEVILLE WAS SHOWN: Whosoever and wherever Christians WILL CRY OUT and INTERCEDE and FIGHT in prayer for this nation to turn back to THE WILL OF GOD BEING DONE, those people and places will be spared.

Bro. Sadhu was told by Moses: BELIEVE THE WORD OF THE PROPHETS and PREPARE. Noah believed and prepared an ark. We are to prepare the Tabernacle of David (day and night prayer). Bro. Sadhu was shown that God multiplied food for Noah's family and all the animals. 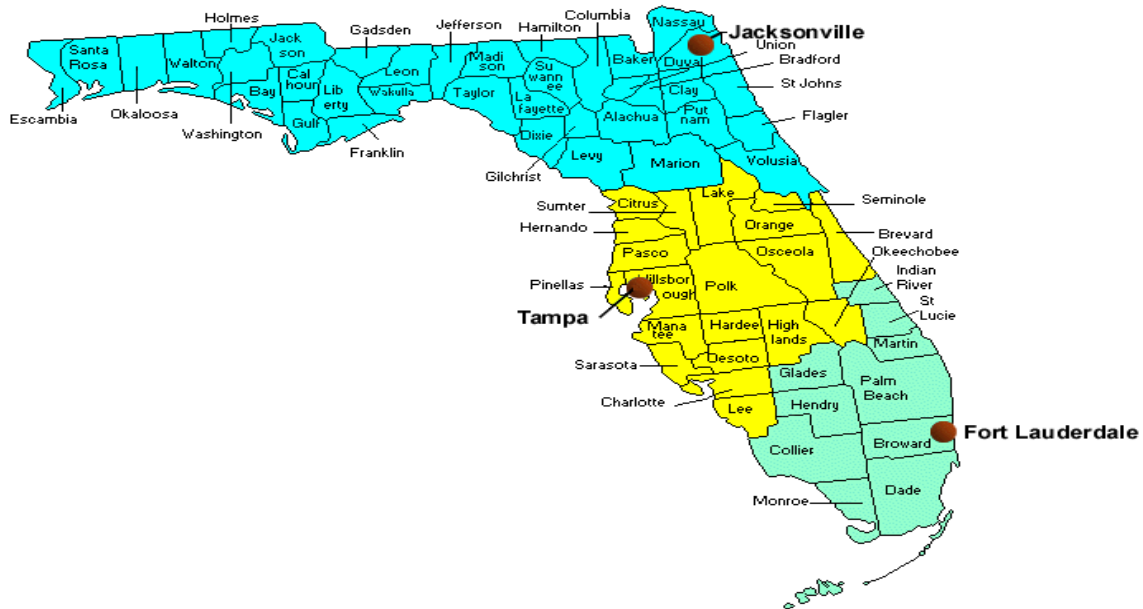

First of all, I would like to thank each of you for the valuable role you serve as a school board member for the Hillsborough County Public School System and the time that you have devoted to ensure that our children who attend the public school system in Hillsborough County Florida receives the best education possible in a safe environment.

The reason for this email is two-fold.

First, it is to bring to your attention to a change which needs to be made to the *Hillsborough County Public Schools Student Handbook*.

Second, it is to beseech you to ensure that the teachers in Hillsborough County use the appropriate resources in order to teach our children the truth about our country's founding and what is in our US Constitution versus what is not in our US Constitution.

As I read through the *Hillsborough County Public Schools Student Handbook*, I found a blatant error on page 25 under the section titled "Religion (HCPS Policy 2270, 5223, 5225, 5780)" which says, "*We uphold the constitutional standard of separation of church and state.*"

The entire section I am referencing in context is as follows:

#### **Religion (HCPS Policy 2270, 5223, 5225, 5780)**

##### **Students have the right to:**

- Study, examine, discuss, criticize, or support religious ideas and institutions for their literary and historic qualities when presented objectively as part of a program of education;
- Release time from school to observe religious holidays, which is an excused absence with written parental permission;
- Practice their religion

##### **Students have the responsibility to:**

- Not endanger the physical health or safety of themselves or other or disrupt the educational process;
- Develop tolerance and respect for the beliefs of others;
- Inform school officials through their parents about any religious practices or beliefs that may be in conflict with school rules or regulations;
- Decide for themselves whether or not they wish to take part in any religious activity

**We uphold the constitutional standard of separation of church and state.**

This statement is erroneous because there is **no** separation of church and state in our US Constitution!

The phrase, "*separation of church and state*" is not written in either the First or Fourteenth Amendment. Rather, these Amendments explicitly state that the U.S. Constitution prohibits the federal and state governments from nationalizing any religion, from creating a national church, and from favoring one religion over another.

Following are the two clauses that comprise the Religious Clause of the First Amendment:

- The Establishment Clause: *"Congress shall make no law respecting an establishment of religion. . . ."* and,
- The Free Exercise Clause: *"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof..."*

The U.S. Supreme Court first cited the phrase, "wall of separation between church and state," in 1947 (*Everson v. Board of Educ. of Ewing*, 330 U.S. 1, 15-16) from a well-known expressed letter by Thomas Jefferson to the Danbury Baptist Association.

While the Supreme Court did rule that a "wall of separation between church and state" exists, they did so based upon seven words from one personal letter rather than from the Constitution. As a result, the Supreme Court created an erroneous precedent, ruling that law could be created from a personal letter instead of the Constitution.<sup>1</sup>

What constitutional standard of separation of church and state are the administrators of our children's education upholding since congress shall make no law respecting an establishment of religion, or prohibiting **THE FREE EXERCISE THEREOF**?

Moreover, when you as an elected official have mandated as a matter of public policy a law (rules) concerning when and how the students can exercise their free right to practice their religion based on their own conscience, are you not in violation of the very constitutional standard that you say that you are upholding?

Therefore, please be sure to address this public policy concerning the separation of church and state that is NOT in our Constitution. Moreover, please let me know when this has been corrected in the student handbook as well.

On another note, I am pleased to see that according to the website below, it is now required that public educational institutions receiving federal funds teach our students about the Constitution on September 17<sup>th</sup> every year. 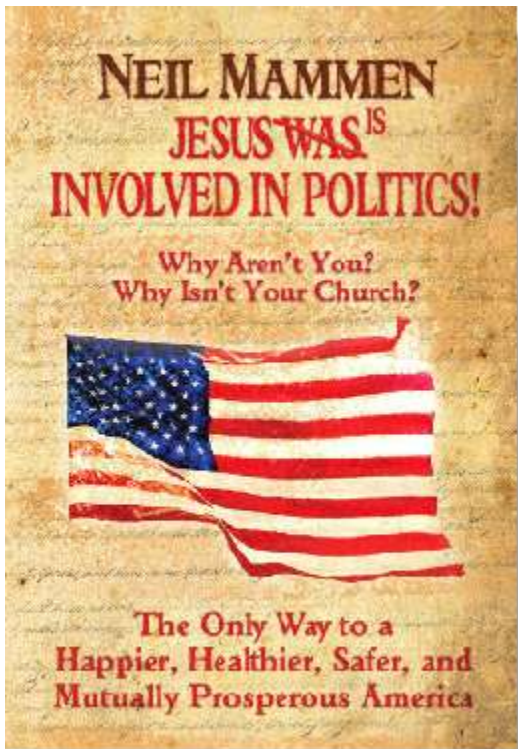
