Operation American Spring-Washington D.C. May 16, 2014



TO:

Patriots (black, white, red, yellow, brown, male, female, civilian, military, truckers, bikers, militias, veterans, old, young, every American that loves freedom and liberty)

Ninth Circuit Stays Ruling on California Change Therapy Ban

Recently, the Ninth Circuit Court of Appeals in San Francisco granted Liberty Counsel's motion requesting the court to stay its recent ruling in *Pickup v. Brown* regarding the California law which bans change therapy.

The law was scheduled to go into effect on January 1, 2013, but Liberty Counsel obtained an injunction blocking the law. Last week the Ninth Circuit Court of Appeals upheld the law, but the decision drew a strong dissent from three judges. Liberty Counsel filed a motion to stay the opinion, and the Court of Appeals granted the motion and stayed the ruling until the Supreme Court acts on the Petition.

Liberty Counsel has filed two similar cases on change therapy in New Jersey, *King v. Christie* and *Doe v. Christie*. Change therapy bans have also been proposed in Massachusetts, Maryland, New York, Virginia, and Washington. Liberty Counsel is communicating with legislators in those states as well. If legislation passes in

other states and minors and counselors ask for our help, we will file similar lawsuits.

Please pray that the Supreme Court grants our petition and overturns the change therapy ban.



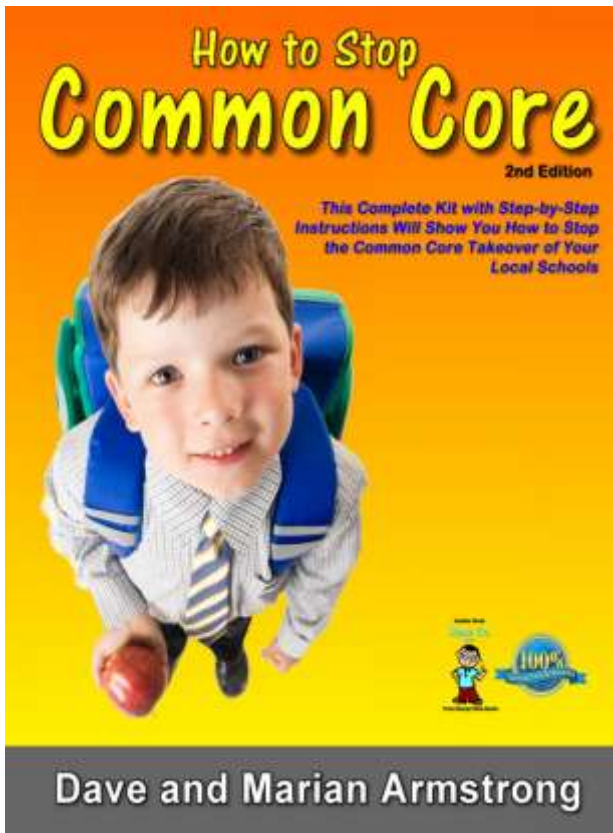

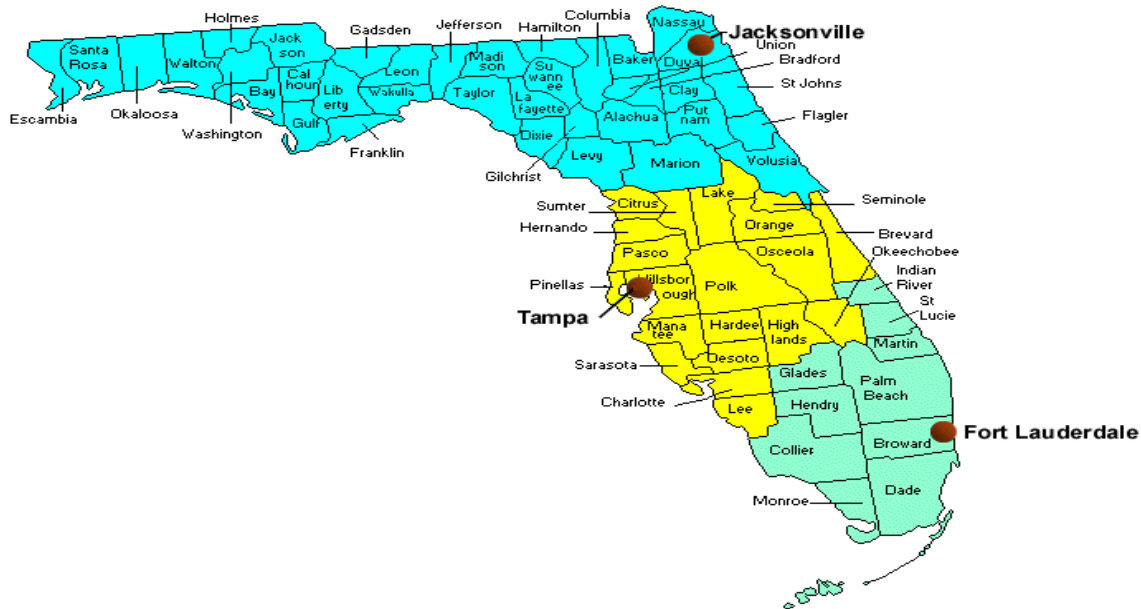

On February 18th at 9 am, the State Department of Education is meeting and voting on Common Core in Florida. Before this occurs, which I realize is less than 2 weeks away, I would like to know that every place a Board of Education meets for each school district has had a visit from a prayer team, and as many schools in each district as well. About the Assignment

There is a law that has been on the books practically since the first case of child abuse was reported to the ASPCA. No, I did not get the acronym wrong and yes it is an agency that protects animals. Before the American SPCC law was passed children suffered abuse and there was nowhere else to turn. This law states that parents do not have complete authority over their children, and so it lays a foundation and something with teeth to defend Common Core. The interview was such a powerful one that I have decided to summarize it for you here in hopes that later some of the points can be dealt with in more detail separately. When I attack an issue, I want to know everything that is involved; I want to see all the pieces so I know how my part fits in with the whole thing.

Prior to this interview I was focused on Common Core, after reading this interview I saw a much larger picture that has changed my battle plan. You see, I saw a lot of things happening, common core, agenda 21, human trafficking, budgets, campaigns, constitution, etc. Now, I have connected the dots and see that they are really ONE very large plate of spaghetti with several meatballs! Let me summarize here and help you see what I have seen, and if you have already seen this, maybe I can add something to your base.

According to our Constitution educational decisions are designated to the authority of the State Governments. Common Core (CC) is a Federal takeover of education and usurps State authority and the Constitution. Common Core encompasses not only public schools, but also, private, Christian and home schooling education systems. It is a one size fits all take over. Children with learning disorders will not be given any special provisions; they will be left behind in a "No Child Left Behind" declaration that is a lie perpetrated on the American public. The public was shown only the icing on the cake and tasted it to see that it was sweet, but as we get down into the cake itself, it is baked with bad ingredients and mixed with poison.

When you put the CC requirements alongside of the tenants of Nazism , you will find more similarities than you feel comfortable with. I.e. Master Teachers to train CC teachers, data files kept on students and teachers, students reporting to the government opinions about parents and teachers, teachers reporting on children and parents to the same government and strong teacher unions. Students will have only the wishes of the government to aspire to as their own dreams will be left on the side lines for what the government has dictated through testing, is the path they should follow. A future that is ever increasing in technology will record facial expressions, seat posture and skin conductive sensors through monitors and computer mice. This is a deliberate dumbing down of our culture (www.diliberatedumbingdown.com)

Communist countries are considered democracies and the Master Teachers are teaching the teachers to be guardians of Democracy. The USA is a democratic Republic To promote the correlation of government and in education, CC will incorporate literature in every class, the classics may be taught 15% of the time but the rest of the time will be designated to the reading of government documents, such as Obama Care and other indoctrination articles, leaving little time really for the other 15% allowed, because the test will cover the government documents and teachers will be paid according to the progress and success of their students on the tests. I have seen excerpts from some of the new textbooks to be used; they distort history, for instance Israel is not on a map of the Middle East, and Palestine is designated as a state. Historical facts, like Washington praying at Valley Forge etc. are no longer relevant as the 5 Pillars of Islam are portrayed on the walls of school hallways and children are taken on trips to mosques.

Agenda 21 is short for UN Agenda for the 21st Century. President Bush (1st) called it the "new world order"! The treaty was never ratified by congress for the USA to participate in Agenda 21. President Clinton signed an executive order to incorporate UN agenda in the President's Council on Sustainability Development an implemented a UN driven agenda that by passed congress.
