On another note, we must pray also against an attack on the United States again. This morning as I prayed, I heard these words: "The walls are down!" I once again have a great concern for Washington DC, the original 13 colonies, (especially New York), California, and military bases. We also need to cover our schools at this time.

BREAKING NEWS: WA State house approves anti-drone bill 83-15

OLYMPIA, Wa., February 17, 2014 – Today, the Washington State house passed a bill putting strict limitations on the use of drones and other “extra-sensory devices” within the state. The vote was 83-15.

House Bill 2789 (HB2789) was filed by Rep. Dave Taylor (R-Moxee) and a bipartisan group of five democrats and six republicans. The bill prohibits the use of drones to collect personal information that “describes, locates, or indexes anything about a person” without a warrant “made in writing, upon oath or affirmation, to a judicial officer...where there is probable cause.” Once such warrants are issued by a judicial officer, the legislation allows their use for ten days. A judicial officer may grant an extension, but for no more than thirty days.

The legislation also bans public agencies from even acquiring drones without specific authorization from the appropriate governing body.

“This bill is about freedom.” noted Rep. Matt Shea (R-Spokane Valley), who co-sponsored the bill. He wasn’t alone in his sentiments.via Washington Tenth Amendment Center

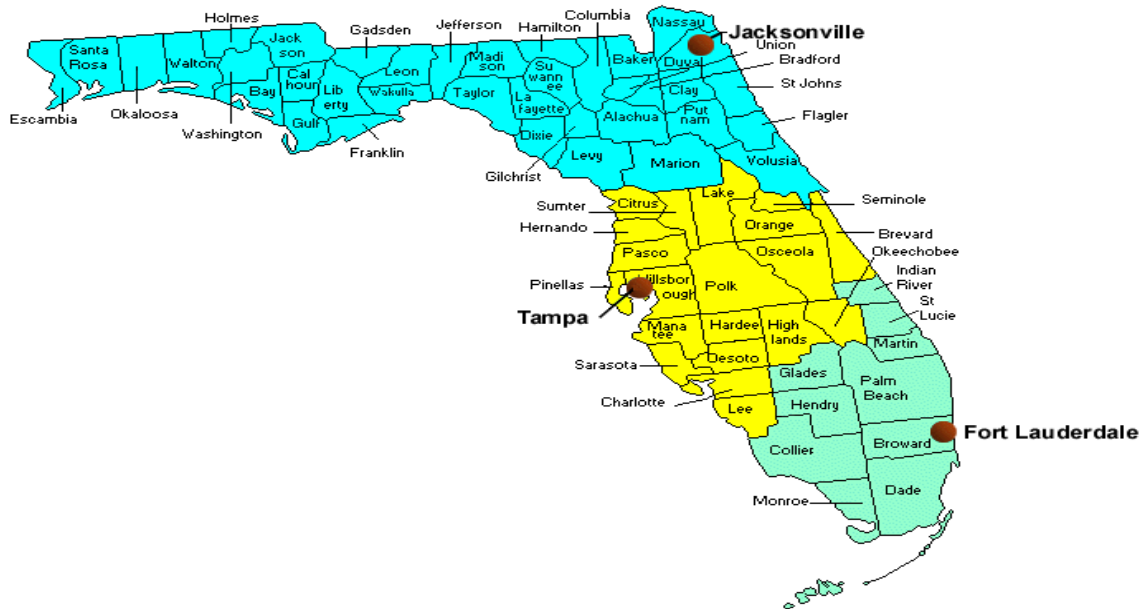

You may state in your contact: [Mr. Ronnie Duncan, Chairman of TBARTA](#), is now serving dual roles. He is chairman of a state agency at the same time he is stepping into the position organizing and leading an effort known as “Yes for Greenlight”, advocating support to pass the sales tax referendum on the November ballot in Pinellas County. This situation constitutes a direct conflict of interest for Mr. Duncan, is counter to TBARTA's Guiding Principles and damages TBARTA's credibility and public trust. The only remedy now is for Mr. Duncan to resign from TBARTA immediately. I ask for your help in looking into this matter and taking the appropriate action asap.

Ronnie Duncan has politicized TBARTA and damaged this agency's credibility. Perception is reality and this blatant public show of cronyism must STOP as the public trust of TBARTA has been broken!

TBARTA represents a 7 county region (including Hillsborough) that will shortly be adding Polk County who also has a transit referendum on the ballot in November. Duncan's dual activities sets a precedence that we must stop now or we have to assume he will do the same thing in any other county in the future. Will Duncan do the same in Hillsborough or your county?

In addition, taxpayer funded PSTA CEO Brad Miller admits that PSTA's taxpayer funded advocacy campaign "Greenlight Pinellas" will be **COORDINATING** with this new private pro referendum advocacy group "Yes for Greenlight". Both campaigns are using the same PR firm, Tucker Hall. Therefore, we must assume more inside coordination. If this is not illegal, it is unethical and wrong!

Background information:

Our Florida Code of Ethics statutes states:

112.311 Legislative intent and declaration of policy.-

(5) It is hereby declared to be the policy of the state that no officer or employee of a state agency or of a county, city, or other political subdivision of the state, and no member of the Legislature or legislative employee, shall have any interest, financial or otherwise, direct or indirect; engage in any business transaction or professional activity; or incur any obligation of any nature which is in substantial conflict with the proper discharge of his or her duties in the public interest. To implement this policy and strengthen the faith and confidence of the people of the state in their government, there is enacted a code of ethics setting forth standards of conduct required of state, county, and city officers and employees, and of officers and employees of other political subdivisions of the state, in the performance of their official duties. It is the intent of the Legislature that this code shall serve not only as a guide for the official conduct of public servants in this state, but also as a basis for discipline of those who violate the provisions of this part.

112.313 Standards of conduct for public officers, employees of agencies, and local government attorneys.—

(7) **CONFLICTING EMPLOYMENT OR CONTRACTUAL RELATIONSHIP.—**

(a) No public officer or employee of an agency shall have or hold any employment or contractual relationship with any business entity or any agency which is subject to the regulation of, or is doing business with, an agency of which he or she is an officer or employee, excluding those organizations and their officers who, when acting in their official capacity, enter into or negotiate a collective bargaining contract with the state or any municipality, county, or other political subdivision of the state; nor shall an officer or employee of an agency have or hold any employment or contractual relationship that will create a continuing or frequently recurring conflict between his or her private interests and the performance of his or her public duties or that would impede the full and faithful discharge of his or her public duties.

1. When the agency referred to is that certain kind of special tax district created by general or special law and is

limited specifically to constructing, maintaining, managing, and financing improvements in the land area over which the agency has jurisdiction, or when the agency has been organized pursuant to chapter 298, then employment with, or entering into a contractual relationship with, such business entity by a public officer or employee of such agency shall not be prohibited by this subsection or be deemed a conflict per se. **However, conduct by such officer or employee that is prohibited by, or otherwise frustrates the intent of, this section shall be deemed a conflict of interest** in violation of the
