"We cannot arrest our way out of this problem: Education is key to prevention."**

Dear Friends,

I do sincerely wish I could always send you good news. But in the world of child sexual exploitation, good news often comes in the package of catching the bad guys and rescuing children. For twenty years, our focus has been on prevention of child sexual exploitation online primarily through education, public policy and law enforcement and through working with the Internet industry to be part of the prevention solution.

This week, U.S. Federal prosecutors charged 14 people involved with an Internet child pornography ring where thoughts of sexually explicit images and videos were shared of children, some as young as 3 years old. Officials are calling Operation Round table "one of the largest online child exploitation investigations in the history of U.S. Immigration and Customs Enforcement" The investigation involved a joint effort between Immigration and Customs Enforcement, the Department of Homeland Security, the U.S. Postal Inspection Service, and the U.S. Attorney for the Eastern District of Louisiana.

The underground website was a hidden service board on the Darknet's Onion Router, also known as Tor which operated from about June 2012 until June 2013, according to a DHS report. "The site contained more than 2,000 videos and had more than 27,000 members. The report states the website shared webcam-captured videos of mostly boys enticed by the operators of the site to produce sexually explicit material."

"So far, investigators have identified 251 minor victims in 39 states, according to the report. Victims also have been identified in the United Kingdom, Canada, New Zealand, Australia and Belgium. Eight of the victims were female and 243 were male, the report states. The majority of victims, 159, were 13 to 15 years old. One victim was between the ages of 4 to 6, and two victims were 3 years old or younger."

"Never before in the history of this agency have we identified and located this many minor victims in the course of a single child exploitation investigation," said ICE Deputy Director Daniel Ragsdale. "Our agency is seeing a growing trend where

children are being enticed, tricked and coerced online by adults to produce sexually explicit material of themselves. While we will continue to prioritize the arrest of child predators, we cannot arrest our way out of this problem: Education is the key to prevention."

Once these images are released, they can never truly be recovered or taken down off the Internet or off the hard drives of collectors of child pornography worldwide.

Education is key. Please review the critical life saving information to protect youth from sexual predators and from their own risky behavior. Watch our award winning **Grooming Video** and **Profile of a Predator video** in which I interviewed a convicted sex offender, "John Doe". In the video, he shares how predators like him operate and gain the trust of youth and what parents and youth need to know to guard against online seduction.

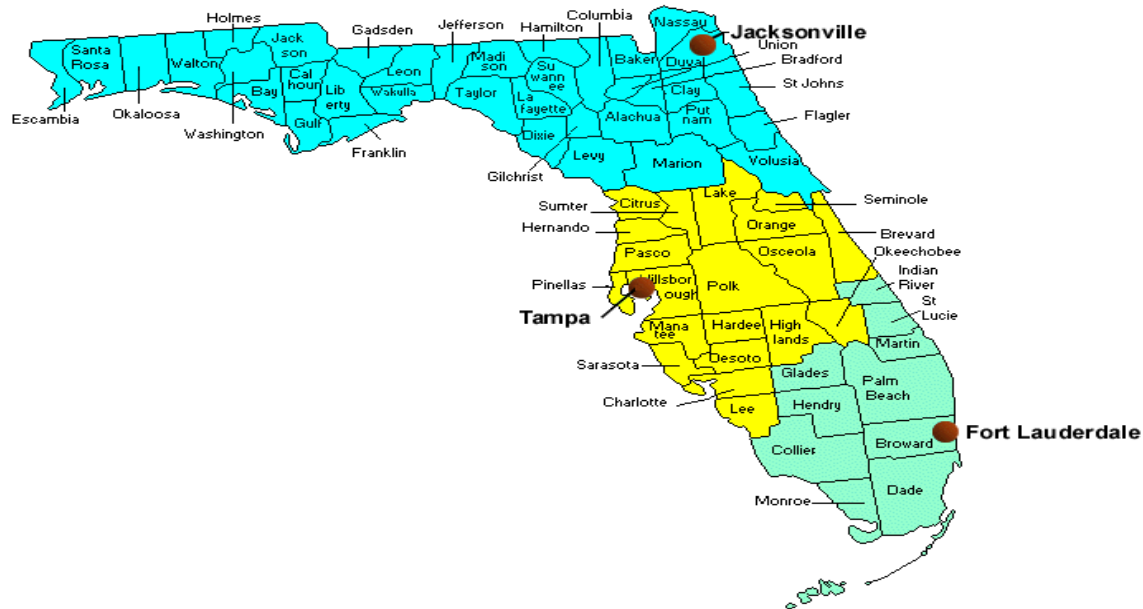

## Action/Prayer/FYI Item #1:

**Contact Governor Rick Scott RE: His support for SB1400 authorizing Illegal-alien students being subsidized for in-state tuition.**

Florida Governor Rick Scott announced his support for SB 1400, a bill that would give illegal-alien students access to taxpayer subsidized in-state tuition. The bill is very similar to HB 851, which will soon get a House floor vote.

Scott is supporting the bill, in part, because it contains his own proposal to place limits on how much state universities can raise tuition each year. While NumbersUSA takes no position on the tuition limitation measure, we argue Gov. Scott should find another vehicle for his plan that does not force taxpayers to underwrite tuition for illegal aliens.

### **Common Core Standards are still moving forward in Florida. Take Action Now Before It Is Too Late!**

There has never been a fiscal study of how much it will cost to implement Common Core. No one really knows how much it will cost your local school district to implement CC. A few years ago the feds bribed Florida with "Race to the Top" money to get our politicians to agree to implement Common Core, but guess what? The Race to the Top money is almost gone so Common Core costs will have to be covered with new money.

Is Tallahassee going to start giving more money to the schools? Maybe, but I wouldn't hold your breath. Most likely new expenses will be unfunded mandates that your local school district will have to cover and they probably don't have the money to do so. That means they will have to cut something else or get more taxes from you, all to implement an education curriculum whose merits have been shrouded in secrecy.

Good public policy is done in the sunlight, not in secrecy. Florida has been conned, we need to tell our elected officials to back out of Common Core. The mood in Tallahassee is that many of our legislators are on the fence and they need to know that we the citizens don't want liberal, ham-fisted, D.C. central planner's data mining our kids and gaming the lesson plans to teach them to be good little servants of the state. These are OUR schools, the schools WE pay for, the schools WE elect school board members to govern, the schools WE and our neighbors send our children to, the FLORIDA schools, not the federal schools.

#### Legislative Subterfuge

Common Core Opponents just returning from Tallahassee report that after meetings with members of the House and Senate Education Committees on the issue of Common Core those legislators and their staff were all working off the same talking points to sidetrack and confuse those opposing Common Core, including the Governor's office.

The Florida Department of Education recently made minor adjustments to Common Core and Rep. Janet Adkins and the K-12 Subcommittee passed a bill (PCB TKS 14-01), that removes references to Common Core and changes the name to the Next Generation Sunshine State Standards or Florida Standards. Remember that last year our Florida legislators redefined the term Next Generation Sunshine State Standards to include Common Core.

This is just a change in semantics with no change in implementation. After just a couple of meetings, it would have been laughable if weren't so sad that they actually think we will be fooled by their subterfuge. Despite minor changes to the standards and a new name, Common Core Standards are still moving forward in Florida.

SB864 and HB921 are both end around bills designed to make the public **believe they oppose Federal intrusion and Common Core standards** (see below). If all the text books we have to choose from are aligned to Common Core, and the students' tests will be based on Common Core, and schools and teachers will be graded on their

students' tests, there is still no choice for school districts but Common Core aligned curriculum, most of which is produced by Pearson PLC and the College Board.

**Senate President Don Gaetz and Speaker Will Weatherford told us in person that these are the bills they support and they will not allow SB1316 and HB25 to be heard in Committee: Why Not? Because, Debby Mayfield's bill HB25, is the only bill that actually will stop Common Core, and they know it.**

**Action Items:**

HB25 is Representative Debbie Mayfield's Stop Common Core bill. Its first committee stop is the House Education Appropriations Sub Committee chaired by Representative Eric Fresen. So far he is refusing to schedule the bill for a committee hearing. Call him at 850-717-5114 and demand that he schedule the bill for a hearing.

Representative Marlene O'Toole is Chair of the House Education committee. Call her at 850-717-5033 and tell her you support HB25 and want it heard in her committee.

SB1316 by Senator Evers is the Senate companion bill to HB25. Senator John Legg is the Chairman of the Senate Education Committee. Call Senator Legg at 850-487-5017 and tell him you support SB1316 and want it scheduled for a hearing in his committee.

Finally, call the Governor's Education Policy Coordinator, Kim McDougal at 850-717-9376. You will get her assistant, Robert Schulte. Tell him you want to speak to Kim McDougal. He will want to take a message for her. Tell him to tell his boss, that her boss, the Governor, will pay a high price at the polls in November if he continues with the implementation of Common Core.

**Take Action on Camera Scheme Repeal Bill! By Paul Henry**

The Senate camera scheme repeal bill has been rescheduled from last week. It will now be heard on **Wednesday March 26, 2014 at 1:30 PM in room 37 of the Senate Office Building**. I will be attending in support of the bill.

Since it was last scheduled, two important things have happened:

The cities of Tampa and Palm Bay have voted to do away with the camera scheme. These cities join St. Petersburg, Margate, and Cocoa Beach in dropping the scheme in 2014.

A March 20 news story from the Orlando Sentinel reports Apopka is considering dropping the scheme. Apopka is the largest money maker in central Florida, and was the 2nd city in Florida to use the scheme. It has consistently sent government lobbyists to Tallahassee to support the scheme since 2011.

**Please let the below Senators know that the writing is on the wall-** the people of Florida recognize an unjust scheme when they see one and are demanding action. The Legislature gave us this bad law in 2010, and they must take it away in 2014. The below information is recycled from the prior email.

At the last hearing, several camera scheme proponents- all government lobbyists and there on our tax dollar-spoke in favor of the scheme. What I noticed was that they realize the safety argument has been lost since red light violation crash data cannot support it. The talking point now being pushed is how the scheme “changes driver behavior”. This is usually supported by fewer “violations” being issued, such as Tampa’s drop from over 6,000/month in March 2013 to under 2,400 in February 2014. What is not mentioned by scheme supporters is that the cities were forced to add just 4/10 of a second to their yellow time last fall (thanks to work by WTSP investigative journalist Noah Pransky), and after this took place, fewer violations were seen. Think what could happen if a full second were used.

One supporter did comment how the scheme saves lives. In that regard, in your calls and emails to the below list, please share the following points taken from the Department of Highway Safety’s “Traffic Crash Facts” annual publication (exception- 2011 data never published by the state, gleaned from a scheme vendor news release):

Fatal red light violation crashes in Florida, past 9 years (2013 not yet published):

2004: 96

2005: 96

2006: 123

2007: 107

2008: 76

2009: 56

2010: 53 (Camera scheme law effective July 1, 2010)

2011: 76

2012: 56

Two main points can be seen:

Without the use of a camera scheme, fatal crashes fell by more than half from 2006-2009.

In the first full year of the scheme (2011) there was a huge increase.

## **ACTION ALERT**

One thing that was pointed out by several senators on another bill was that they had not heard anything from anyone on the issue. I'm sure that is not the case with the camera scheme, but nonetheless we should use the time to redouble our efforts to convince the committee members via their listed aides that they must vote for repeal. I have included Sen. Clemens in this list although I consider him a lost cause due to his filing of an amendment to SB 1342 last session that gutted the camera scheme reform bill and turned it 180 degrees.

**Senate Bill 708, which recently passed its final committee of the current legislative session, most significantly creates a Homeowner Claims Bill of Rights that insurance companies will be required to give to every policyholder who files a claim.**

Dear Fellow Floridians:

As Florida's Chief Financial Officer, I am contacted every day by consumers who have become overwhelmed, frustrated and confused by the insurance claim-filing process. More than 300,000 Floridians in the midst of a stressful situation involving a damaged or lost home have called my office with questions about what to do, who to call, what to expect and when their maintenance and financial problems can finally be resolved.

In an effort to simplify the claims-filing process and alleviate the stress it creates, I am working with the Florida Legislature to establish common sense safeguards. Senate Bill 708, which recently passed its final committee of the current legislative session, most significantly creates a Homeowner Claims Bill of Rights that insurance companies will be required to give to every policyholder who files a claim. The Homeowner Claims Bill of Rights is a one page document that is easy to understand and clearly outlines policyholders' rights under Florida law. Most importantly, however, the bill of rights will provide simple instructions to make sure your insurance claim needs are met fairly, timely and in accordance with the law.

Furthermore, our legislation requires that an insurer's underwriting process be completed in 90 days or less. Policyholders should not be denied their claim if the sole reason for denial is credit-related information that has been available for insurers to access in public records for months.

The bottom line is that homeowners already have enough to worry about when dealing with a lost or damaged home. They need a clear direction in which to proceed and the confidence that they can navigate the claims filing process without becoming overwhelmed or making a detrimental decision that only adds to their problems.

You have my assurances that I will work tirelessly to help pass this important piece of legislation. I am also calling on insurers to enthusiastically support this bill because they should want their customers to be as educated as possible and fully prepared to navigate the claims process.

Senator Charles Dean introduced the bill and a newly amended version of the bill. Following the approval to consider the amended bill, he yielded to Senator David Simmons to explain the bill.)

After questions from the committee, public testimony was heard. Many environmental groups spoke in support of the bill giving it wonderful accolades. A few others spoke cautiously about the bill. CPR was present and offered reasons as to why the bill will not accomplish its stated objectives using the points outlined in our last newsletter.

No Senators on the committee were persuaded to consider such challenges, citing the need to “*do something now.*” Each Senator on the committee voted favorably to send the bill on to its next committee, the Senate Agriculture Committee. The Agriculture Committee usually meets on Monday but, it will not be meeting on March 24.
