### **Liberty Counsel Defends Michigan Marriage Amendment**

Cincinnati, OH – Late yesterday, Liberty Counsel filed an [amicus brief](#) at the Sixth Circuit in Cincinnati defending the Michigan Marriage Protection Amendment (MMPA) on behalf of the American Family Association of Michigan, which was one of the coauthors of the amendment.

In 2004 voters overwhelmingly approved the amendment to the Michigan Constitution: "To secure and preserve the benefits of marriage for our society and for future generations of children, the union of one man and one woman in marriage shall be the only agreement recognized as a marriage or similar union for any purpose." On March 21, 2014, the district court found that the MMPA was unconstitutional because it violated equal protection, and the case is on appeal to the Sixth Circuit Court of Appeals.

"Michigan voters were exercising a fundamental right when they amended the Constitution, and that right should not be diminished by a court repealing the amendment," said Mat Staver, Founder and Chairman of Liberty Counsel. "The U.S. Supreme Court just upheld the right of Michigan voters to amend their Constitution to end affirmative action, and we argue that the Court's decision applies equally to this amendment."

"The MMPA, like similar amendments and statutes throughout the country, memorializes, but does not create, the definition. Marriage is defined by its nature and predates government, which is limited to regulating marriage in accordance with its natural, historical definition," Liberty Counsel told the court in its [amicus brief](#).

The Supreme Court has upheld marriage as a foundational social institution that is necessarily defined as the union of one man and one woman:

- Marriage is "fundamental to the very existence and survival of the race." *Skinner v. Oklahoma*, 316 U.S. 535, 541 (1942).
- "An institution in the maintenance of which in its purity the public is deeply interested, for it is the foundation of the family and of society, without which there would be neither civilization nor progress."

Maynard v. Hill, 125 U. S. 190 (1888).

"Marriage is not merely a creation of any one civilization or its statutes, but is an institution older than the Constitution and, indeed, older than any laws of any nation. Marriage is a natural bond that society or religion can only 'solemnize,'" Staver concluded.

### **Family Research Council's Prayer Targets: Franklin Graham; HHS Mandate; Marriage Update; Abortion/Life Update, More**

Dear Praying Friends,

[Franklin Graham](#), son of Evangelist Billy and Ruth Bell Graham, has been president of the Billy Graham Evangelistic Association (BGEA) since 2001. Since his first evangelistic crusade in 1989, Franklin has preached to more than 7 million people around the world. In his early 20's, Franklin joined the ministry of Samaritan's Purse (SP), an evangelical international relief agency. In 1979, after the death of SP founder, Dr. Bob Pierce, Franklin became president and continues in that role today. Graham's leadership is not only distinguished by his passionately persistent invitation to receive the Good News of Jesus Christ and for Christians to show the love of Christ in practical ways, but also for believers to pray and act to impact our culture and nation for righteousness:

*[It] was particularly jolting when those who call themselves Christians departed from the clarity of God's Word, as the leadership of World Vision U.S. did in March when they announced their employment of "gay Christians in legal same-sex marriages." The very day World Vision announced its great compromise on a basic truth of Scripture-that a homosexual lifestyle is sin and that marriage is between one man and one woman-the Supreme Court began hearings to determine if the Green family, owners of Hobby Lobby, should be required to provide life-terminating drugs and devices in their employee health care plan, contrary to the Christian family's spiritual convictions.*

*The contrast was stunning. While the Christian-owned business stood up against a federal government bent on forcing them to compromise the right to life, a Christian charity compromised the sacredness of marriage, stating that "it's the right thing to do for unity within the church." Forty-eight hours after World Vision's announcement, they were forced to reverse their epic decision after a flooding backlash from offended donors.*

*The Bible gives strong warning to those who tamper with God's truth. "From among yourselves men will rise up, speaking perverse things, to draw away [followers] after themselves" (Acts 20:30).*

*The charity's original announcement was personally shocking to me because World Vision and Samaritan's Purse were founded by the same man, my mentor and dear friend, the late Dr. Bob Pierce. Much of my adult life has been guided by something he often said: "I want my heart to be broken by the things that break the heart of God." I believe the heart of God was broken by the decision of the board of directors of World Vision. This is no small matter. I was as grieved by it as I have been by anything in my lifetime of ministry, because the heart of World Vision was revealed-a disregard for biblical truth.*

*There was a day when World Vision's board was made up of people who believed in, and stood on, God's Word, but in making this decision they completely disregarded Scripture and made a decision based on what they perceived as public acceptance and popularity.*

*I do rejoice that the board of directors reversed its decision, but I pray that the fallout will cause a depth of soul-searching. True followers of Jesus Christ, whose salvation is based entirely upon God's Word, cannot endorse same-sex marriage, regardless of what our President, the Congress, the Supreme Court, the media or the latest Gallup poll says about the matter. This moral issue has been settled by God Himself and is not subject to man-made revisions or modifications. In the end, I would rather be on the wrong side of public opinion than on the wrong side of Almighty God who established the standard of living for the world He created. Marriage is a biblically moral issue, not a political or theological one... (Franklin Graham, "The Flood of Compromise," [Decision Magazine](#), April 29, 2014).*

Even a few years ago, who would have believed Americans would divide over what constitutes marriage or that even professing Christians would become confused about it. This is a Mt. Carmel moment for God's people. We cannot side step it and call ourselves Bible-believing Christians. May God help us to prevail in prayer!

**HHS Mandate, Hobby Lobby, etc.** - A new FRC-commissioned [national survey](#) shows that a majority of Americans remain fixed in their opposition to the HHS mandate, disagreeing with the government measure that requires Americans to participate in providing procedures that violate their religious beliefs. The [53%](#) who oppose the Mandate cross age, income, party, gender, and ethnic lines. Meanwhile, three hundred plaintiffs filed 96 lawsuits against the HHS Mandate, which requires all employers who provide employee health insurance (except some exempted for political reasons) to include free coverage for contraceptives and sterilization, including the abortifacient "morning after" pill. Cases were filed by 48 non-profit groups and 48 for-profit businesses. Considering the merits of the cases, courts have granted 21 injunctions to non-profit groups to prevent the administration from imposing fines against them and have denied one. Among for-profit groups, 34 injunctions have been granted and 6 were denied. Ten cases have been dismissed on procedural grounds and 14 are awaiting court decisions on their requests for an injunction. (see [Good Mandate Hard to Find](#); [Information Central](#)).

- ***May God guide the U.S. Supreme Court to rule in favor of Hobby Lobby, and all employers whose faith is violated by the HHS Mandate! May Obamacare be overturned! (Dan 3:14-18; 6:10; Acts 5:29; 23:1; 24:16; 1 Tim 1:5, 9; Rev 12:11)***

**Marriage War Update** - Tuesday, **Idaho** U.S. Magistrate Judge Candy Dale ruled Idaho's Marriage Amendment unconstitutional, overruling 63% of Idahoans who had voted in favor of man-woman marriage. Late last Friday, Sixth Judicial Circuit Judge Chris Piazza overruled 75% of **Arkansas** voters who in 2004 ratified their state's Marriage Amendment. Yesterday, a three judge panel in **Virginia's** U.S. Court of Appeals for the 4th Circuit heard arguments over a District Court Judge's decision to overturn Virginia's Marriage Amendment, ratified by 57% of voters in 2006. The effort was promoted by newly elected Attorney General Mark Herring (D). Courts in **Utah, Oklahoma, Kentucky, Texas, Michigan, and Ohio** have also recently struck down marriage laws. The ACLU and collaborators have targeted all states that hold to natural marriage. Billionaire Tim Gill has dedicated millions of dollars to overturn marriage laws in the Bible Belt (see [Idaho](#); [Arkansas Chaos](#); [Virginia](#); [Gill's Southern Strategy](#)).

- ***May God stir His people to speak the truth in love and to stand up to public officials who seek to destroy Biblical marriage! May the SSM Trend be reversed and may natural marriage proponents prevail in the courts and legislatures (Lev 18:22-130; Mt 19:4-6; Eph 4:14-15; Jude 7).***

**Abortion/Life Update** - Over 60 members of the North Dakota legislature have written Attorney General Wayne Stenehjem, asking him to appeal U.S. District Judge Daniel Hovland's ruling that the fetal heartbeat law they passed is unconstitutional. They hope the case will make its way to the U.S. Supreme Court and reopen

*Roe v. Wade*. U.S. Sen. Lindsey Graham (R-S.C.) hopes to see action on his *Pain-Capable Unborn Child Protection Act*, which Majority Leader Harry Reid (D-Nev.) promised to consider "take a look" at it. Sen. Richard Blumenthal (D-Conn.) also hopes to pass new measure that would pre-empt state laws requiring medical tests before receiving the morning-after pill and abortions.

Blumenthal and other abortion advocates can see that the pro-life movement has tremendous momentum. Between 2011 and 2013 more pro-life bills were signed into law than during the previous [decade](#). Last year [70 pro-life bills](#) were introduced in 22 states. By March 31 of this year, [303 pro-life](#) bills had been introduced in 38 states; three had been enacted; and 36 had passed one chamber. A January 2014 Marist poll found [that 84%](#) of Americans think abortion should be restricted.(see [World of Pain](#); [Senator Seeks to Preempt Pro-life States](#); [Pro-life Momentum](#); [FRC's Arina Grossu](#)).

- ***May the pro-life message continue to gain momentum in the states and in Washington! May God and His people propel each pro-life effort, stop the pro-abortion efforts, and ultimately overturn Roe v. Wade! (Gen 9:6; Ex 20:13; 21:22-25; Dt 30:19; Mt 18:6; Jn 10:10)***

Finally, please pray for Nevada believers, whose state RNC is [rolling the dice](#) by abandoning the pro-life, pro-marriage planks in their national party platform. Yet [82% of Republicans and GOP-leaning independents](#) in Nevada believe in marriage "as between one man and one woman." 

## Florida Family Action is Now Hiring Field Directors across the State of Florida

### JOB DESCRIPTION

#### Florida Regional Grassroots Field Directors

#### General Purpose/Summary Statement:

Full time grassroots field director positions will be hired immediately for each of the following county regions: **Orange/Seminole, Hillsborough, Pinellas, Broward and Dade**. The position will be maintained and funded through the end of the general election in November 2014. Directors for other key regions of the state like may also be hired in the future should funding become available.

#### Essential Duties/Responsibilities:

To open and operate a dedicated field office as a base to operate volunteer **phone banks** and volunteer **precinct walks** and participate in an overall statewide get out the vote campaign.

Field Directors will be expected to report for a work day in the local affiliate Florida Family Action field office Monday through Friday (*and Saturday's as needed / or scheduled.*) A field director would spend a typical workday calling and e-mailing potential volunteers and recruiting them for a phone banking effort and securing volunteers to participate in pre-scheduled door-to-door precinct walks. Phone banks can be operated during the day but will also need to be operated during the evening hours of week days as well. Field directors will also attend local afternoon and evening meetings with activist groups as an ambassador and a representative of Florida Family Action, making announcements about the need for volunteers and explaining the goals.

Field directors may be also asked to assist with local responsibilities and projects including (but not limited to) local and legislative issues, local events including rallies/fundraisers/dinners, etc.

Field directors will be responsible for monitoring, tracking and providing reports of actual results on a weekly basis and more often if requested.

Field directors are expected to regularly use and monitor social media such as Facebook and Twitter as a means of volunteer recruitment, communication and follow up. Some training will be provided.

Field directors will participate in regular team meetings by phone and occasionally in person.

Some occasional overnight travel will be required for training and team meetings in Orlando.

#### Other Duties/Responsibilities:

Each field director will be expected to put in a *minimum* of a full-time work week (40 hours +). Working some overtime and evenings should be also expected on as part of the position. Applicants are expected to devote full-time to this position without engaging in other gainful employment during this period of employment. Any

other employment, income producing work must be approved in advance.

### **Working Environment/Physical Requirements:**

Maintaining office working environment as well as limited travel for training or outside meetings with allied organizations. Director must currently reside in (preferred) or be willing to relocate to the region the field office will be located during the time of employment.

Experience in political campaigns helpful but not required
