Stop Radical Judge Urge your Senators to Oppose Confirmation of David Barron

Right now the Senate is considering whether to reject one of Obama's most radical nominees to the federal bench. If you act now and contact your Senators, he can be blocked.

David Barron has been the source of considerable controversy for both sides of the aisle. In 2010 he authored legal memos on behalf of the Obama Administration justifying the extra-judicial killing of American citizens via drone strike. Since then, the White House has refused to release these memos and has denied the public any glimpse into how Barron handled important legal questions regarding the due process clause of the Constitution and the Fifth Amendment's right to trial by jury.

The fact that David Barron authored memos that even the Left finds alarming and unprecedented should give anyone pause.

Barron is a warrior for what he calls "progressive Constitutionalism," a viewpoint that sees the Constitution as a "dynamic document" in need of interpretation in the light of the "progressive tradition" to avoid the pitfalls and "deficiencies" of originalism.

Barron openly embraces judicial activism in creating and defending abortion rights. As he explains it, sometimes you need to fudge a little bit to get what you want: "unfortunately clarity, candor and activism cannot co-exist without raising serious democratic objections, for some constitutional principles [such as those in *Roe*] demand flouting popular will. Thus, given the costs of foregoing activism, candor and clarity seem a preferable choice for sacrifice."

There is little doubt that Professor Barron, if confirmed, would use his position on the First Circuit to legislate from the bench. The role of a judge is to apply the law to the facts, not to abuse an unelected post in advancing preferred policies against the will of the people.

Please urge your Senators to oppose confirmation of David Barron to a lifetime appointment to the First Circuit Court of Appeals.

Marriage Rulings Par for the Courts in Oregon and Pennsylvania over the Courts' Decisions to Strike Down their Marriage Laws

Oregon and Pennsylvania didn't have much in common -- until this week. Separated by thousands of miles, the two states united in outrage over the courts' decisions to strike down their marriage laws barely 24 hours apart. In Oregon, the 10 year-old marriage amendment was toppled in district court, where the state's attorney general refused to defend it.

Like a dozen black-robed activists before him, Judge Michael McShane [argued](#), "Because Oregon's marriage laws discriminate on the basis of sexual orientation without a rational relationship to any legitimate government interest, the laws violate the Equal Protection Clause of the Fourteenth Amendment to the United States Constitution." The state's failure to defend its own constitution, and the failure of an [openly homosexual judge to recuse himself](#), demonstrate what an overreach this decision was. The deluge of rulings hit Pennsylvania next, where Judge John Jones wrote one of the harshest opinions yet, insisting that laws affirming natural marriage should be discarded "into the ash heap of history."

While both judges cited the Supreme Court's June decisions as a rational basis to destroy marriage, the high court said nothing that would give a federal judge the right to redefine marriage. In an interesting twist, both rulings came down within hours of Politico's new polling -- which showed that a clear majority of likely voters in swing states (52-48%) are digging in on their support of natural marriage.

The courts can ignore natural law, or even suppress it, but they will never succeed in subduing it.



There is absolutely no doubt in my mind that the biggest reason America is in the mess that it's in today is directly due to the apathy and indifference of the American pulpit. Consider these statistics of Christianity in America: Eighty-four percent of the inhabitants of this nation say they believe in the deity of Jesus Christ, according to Barna Group, and 45 percent claim to be born-again Christians. Other studies show it is closer to 33 percent. Either way, these numbers are high. Seventy-seven percent believe their chances of going to heaven are excellent. Thirty-three percent believe one day everyone will go to heaven. Yet America has the highest percentage of single-parent families in the industrialized world, the highest abortion rate, the

highest rate of sexually transmitted diseases, the highest rate of teenage birth by far, the highest rate of teenage drug use and the largest prison population per capita than any country in the world.

Consider also the great moral decline of the last generation (50 to 60 years) and these telling statistics in America. The divorce rate has doubled, teen suicide has tripled, reported violent crime has quadrupled, the prison population has quintupled, the percentage of babies born out of wedlock has risen sixfold, couples living together out of wedlock have increased sevenfold, and gay marriage is now a legalized reality in a number of states, with many believing the end is not in sight.

THE PROBLEM HAS BEEN THAT THE REAL GOSPEL HAS NOT BEEN PREACHED NOR LIVED.



Thank you to all of the citizen lobbyists and to the **Liberty First Network** for all of the hard work alerting legislators of the damage these bill will cause. Although they did not listen to everything we said, your effort made a difference.

Action/Prayer/FYI Item #2:

The Liberty First Network has had some impressive influence in Tallahassee this year.

This session we introduced the newest member to our team, bringing our organization to 3 professional lobbyists. We took on 3 diverse legislative issues for this session.

John Hallman started our session dedicated to protecting your property rights and fighting any changes to Stand Your Ground. It was a large fight to take on, as one of the proponents for changing Stand Your Ground (and publicly against our efforts) was Marion Hammer with the NRA.

Due to John's tireless work, his detailed analysis of the legislation and YOU the grassroots, the bill was stopped in the state senate and never taken up in the state house.

There was also a budget victory in the property rights issues: Environmental groups had requested \$100 million for the Florida Forever land-buying program.

The budget negotiators agreed on \$12.5 million for Florida Forever and another \$5 million for

agricultural conservation easements. Another \$40 million was provided from the possible sale of non-conservation lands.

The \$17.5 million in new revenue for conservation lands overall is less than the \$31 million provided last year for Florida Forever and agricultural conservation easements.

During the Jeb Bush years, Florida Forever was receiving \$300 million per year.

Our newest legislative consultant, Danielle Alexandre, stood up for our booming Microbrewery Industry. This legislation changed drastically over time. There were last minute amendments and several votes as this legislation moved through the process. She stayed focused on this fast moving legislation and kept YOU up-to-date every step of the way.

In the end, this legislation, although passed in the senate, was stopped in the house because of her, and your work.

Paul Henry, continued his fight against Red Light Cameras. His diligent attention to the issues ensured that YOU were informed of an obscure amendment put into an unrelated transportation bill that would force all Red Light Camera tickets to be fought in front of an unelected magistrate. **After Paul put out his action alert and you contacted the legislators, this amendment was removed.**

While all of these achievements are exciting, our work is far from over. In fact, it is really just beginning.

We have already started working on the 2015 session to fight for less government regulation in our homes and businesses. We are also working on some positive pieces of legislation to present in Tallahassee this upcoming session.

We are also happy to announce that Danielle Alexandre will be the Liberty First Network's 3rd registered lobbyist. This is a welcomed addition to our team and will bring a new dynamic in the field of business regulations. Her tenacity and impressive resume will enable our team of lobbyist to work at an even higher level for you.

We have put together a comprehensive plan and budget for the 2015 legislative session. Danielle Alexandre will be a lobbyist for Liberty First Network next year, bringing our organization to 3 professional lobbyists. Along with our lobbyists we have plans to be in Tallahassee for the entire 4 months of committee weeks and session dates. That will put our lobbyists on the front lines fighting for you. Our budget includes researchers and administrative costs and is done for a fraction of the cost of a Tallahassee lobbying firm. See our budget by accessing the following link.

Action/Prayer/FYI Item #3: Florida Town Threatening Volunteers Who Feed Homeless

" A group of volunteers who have prepared food for the Daytona Beach homeless population – or anyone who is hungry, the organizers say – for the past year were given citations and trespass warnings by law enforcement this week.

The city, like dozens of local municipalities across the United States, is attempting to discourage groups outside the approved channels from offering assistance, in hopes of funneling charity to centralized homeless services in the area, the Daytona Beach News-Journal reported.

“The ordinance is there, so if we catch you, we're going to cite you,” Police Chief Mike Chitwood said. “If you want to feed people, and you want to do a good, Christian act, we encourage you to coordinate with the social service agencies.”

Chico and Debbie Jimenez, founders of Spreading the Word Without Saying a Word, and their volunteers were targeted this week at Manatee Island Park despite their reportedly responsible, respected efforts to feed the hungry. Their citations amounted to threats of a \$273 fine for trespassing and \$100 fine for facility use without a permit. "
