Contact Your Senators and Urge them to Oppose—S. 815- Employment Non-Discrimination Act

Employers know best what qualities or characteristics are relevant to performing a particular job, not the federal government. So why does Congress want to inject itself into business owners employment decisions?

This is the question that needs to be asked as the Senate moves to vote on the so-called Employment Non-Discrimination Act (ENDA), a bill that would prohibit businesses from taking into account any conduct related to "actual or perceived sexual identity or gender identity" when making employment decisions even if it violates their religious beliefs or if it is inappropriate for their workplace.

ENDA would force religious business owners and workplaces such as Christian bookstores, religious publishing houses, pre-schools and religious television and radio stations to accept as normal any employee who has had a sex-change surgery, any employee who has changed or is "transitioning" their public "gender identity" (regardless of whether they have had surgery or hormone treatments), transvestites (people who dress as the opposite sex on an occasional basis for emotional or sexual gratification), and drag queens or drag kings (people who dress as the opposite sex for the purpose of entertaining others).

Making matters worse, "perceived gender identity" status does not require sex-change surgery, so ENDA would allow some biological males (who claim to be female) to enter and even appear nude before females in bathrooms, locker rooms, and showers. Situations like this have already been reported in several states with ENDA like laws such as Maine, Colorado and California.

ENDA offers no guidance on how employers should deal with these situations and opens them up to costly lawsuits by inviting disgruntled employees to sue for "discrimination" over a characteristic (in the case of sexual orientation) which is not even visible and of which the employer may have been unaware. This has already been seen in the case of public employers (which are explicitly covered by ENDA) where such laws at the local and state level have led to large settlements being paid at taxpayers' expense.

According to the IRS, 501c3 Christian churches, ministries, and organizations may **NOT** do the following:

1. Expose conspiracies.
2. Criticize the New World Order
3. Say or publish anything negative about ANY politician, Republican or Democrat.
4. Criticize government agencies and bureaus – the IRS, FBI, BATF, CIA, EPA, DEA, OSHA, DOJ, etc.
5. Criticize an institution of government such as the White House, the Congress, the Federal Reserve Board (even though this is a PRIVATE corporation) or the Supreme Court.
6. Encourage citizens to call or write their congressman, senator, governor, mayor, or other public official.

7. Criticize any proposed or pending bill or legislation that would take away the rights and freedoms of the people.
8. Make disparaging remarks about, or criticize, any other faith group, cult, or religion.
9. Expose or criticize the New Age Movement.
10. Support or encourage a law-abiding citizen's militia (even though this is constitutional).
11. Support or encourage the Second Amendment, the right of the people to keep and bear arms.
12. Discourage young women from getting an abortion, or endorse the pro-life movement.
13. Teach that abortion, especially partial birth abortion, is murder and is the killing of innocent babies.
14. Identify homosexuality as a sin and an abomination to God.
15. Express an opinion on any subject or issue.
16. Appeal to peoples' emotions by employing an evangelization method (such as "fire and brimstone" preaching) not considered a "reasoned approach" by the IRS.
17. Discuss or identify threats to Christianity.
18. Discuss subjects or topics the IRS deems "sensationalist."
19. Criticize well-known public figures or institutions the IRS deems "worthy," such as the super-rich elite, international bankers, the Hollywood movie industry, etc.
20. Publish or broadcast information on any topic without giving credence to the opposing viewpoints of Christ's enemies.
21. Publish and offer books, tapes, or products that expose the elitist plot against humanity and God.
22. Criticize the Pope or the Vatican, or contrast the New Catholic Catechism with the truths found in the Holy Bible. (Note: only liberal churches are permitted by the IRS to criticize the Catholic Church).
23. Criticize the United Nations or such globalist groups as the Council on Foreign Relations, the Bilderbergers, and the Trilateral Commission.
24. Criticize the Masonic Lodge, the Order of Skull & Bones, or other Secret societies.
25. Highlight or otherwise bring attention to immorality of public officials or corruption in government.
26. Complain of government wrongdoing or injustice, such as happened at Waco, Ruby Ridge, and elsewhere.
27. Criticize the Jewish ADL or other Jewish lobby groups.
28. Say anything positive about the "religious right" or the "patriot movement."
29. Support home schooling, home churches, or unregistered churches.

30. Spend money on missionary projects or charitable causes not approved by the IRS.
31. Promote or encourage alternative healthcare (herbs, vitamins, etc.).
32. Expose false teachings of any kind by anyone.
33. Support or encourage persecuted Christians suffering under anti-Christian regimes in Red China, Cuba, Russia, Israel, Saudi Arabia, the United States, and elsewhere.
34. Ordain a pastor whose training or qualifications are not approved by the IRS.
35. Advocate or teach any Bible doctrine that is politically or religiously incorrect, or is inconsistent with any “public policy” (abortion, feminism, gay rights, etc.) currently being enforced by the IRS.

Additional requirements for 501c3 churches are found in the Department of the Treasury Internal Revenue Service Publication 1826 (9-94) Cat. no. 21096G, churches must:

36. Have a recognized creed and “IRS approved form of worship.”
37. Have “IRS approved code of doctrine and discipline”.
38. Have ordained ministers educated in “state accredited colleges.”
39. Pastor must answer to the IRS as to “daily activities of the church.”
40. The IRS must be privy to “all financial transactions” of the church.
41. Pastor must supply “names of all donors” – make books, records available.
42. Be neutral on political issues.
43. Be engaged in activities furthering exclusively public purposes.
44. Open its services to the public.
45. Submit names of all church workers; pastors, teachers, clerks, counselors, educational directors, office help, associates, and maintenance personnel.
46. Not publicly oppose licensing of church ministries.
47. Give unlimited submission to civil magistrates pertaining to all laws – federal, state, and local – including public policy.
48. May only use “IRS approved” fundraising methods.
49. Pastor will be “called to account over any stand taken against the tax system.”
50. Church “must advocate and support racial integration.” (Multiculturalism)
51. May NOT engage in activities “opposing pornography.”

52. May NOT support legislation saying “children belong to parents” rather than “the state.”

53. May NOT form a Political Action Committee nor support legislation “opposing lotteries and gambling activity.”

54. May not “oppose the public school system.”

55. May “not publicly declare” we are to “obey God rather than the government.”

56. May Not advocate support of the United States or state constitutions as the supreme law of the land. (Public policy takes precedence.)

The “Christian” Church has been gutted. It has had its “heart” and all of its inward parts removed just as completely as a slaughter-house animal on its way to being dismembered for market. The “Church” can SAY nothing and DO nothing

In addition, according to this article titled, *501(c)(3) The Devil’s Church*” do you know when you sign-up as a *501(c)(3) corporation* you have agreed to give up your constitutional rights!? Following is an excerpt from this article titled “*501(c)(3) The Devil’s Church*”

“A 501(c)(3) corporation, being an artificial person, is not considered a person under the First Amendment to the United States Constitution (religious liberty clause) or under the Fifth Amendment to the United States Constitution (protection against self-incrimination clause). Therefore, an incorporated church has NO First or Fifth Amendment rights. In the case Johnson vs. Goodyear, 127 Cal.4 (1899): ‘A corporation, being an artificial person, only has rights within the meaning of the due process and equal protection clauses of the Fourteenth Amendment to the United States Constitution and similar provisions of State constitutions and within the meaning of state statutes.’” [i.e. Your 501(c)(3) church has no constitutional rights.]

A 501c3 church corporation is by lawful state definition:

- The creator of a corporation is the State.
- The State is the sole authority and sovereign head over the corporation.
- The corporation is subject to the laws of the State which limits its powers.
- The corporation has no constitutionally protected rights.
- The corporation is an artificial person.
- The corporation submits to a State Charter declaring it is a creature of the State.
- The corporation is created for the benefit of the public.

- The corporation is a State franchise.
- The corporation is a privilege granted by the State.

*“Pastors, evangelists, missionaries, elders, deacons, watch this carefully because I need to make this abundantly clear. You have a 501c3 INCORPORATED status. That means **your church is a corporation of the state**. Here is the message that I, other preachers, and the IRS is trying to get you to understand about the contract you signed”:*

- The creator of your church is the State.
- The State is the sole authority and sovereign head over your church.
- Your church is subject to the laws of the State which limits its powers.
- Your church has no constitutionally protected rights.
- Your church is an artificial person.
- Your church submits to a State Charter declaring it is a creature of the State.
- Your church is created for the benefit of the public.
- Your church is a State franchise.
- Your church is a privilege granted by the State.

*“Before we continue, any Christian ought to be able to see the clear Biblical violations a 501c3 incorporated church is committing! Once a preacher has signed the papers, it does not matter who the pastor says his creator is when he's up on the pulpit, because **he signed a document denouncing the Lord Jesus Christ as his creator, and put the state in His place**. It does not matter who the pastor says is the sole authority and sovereign head over the church he's preaching at, because **he signed a document declaring that the State has authority over the church of Christ**. It does not matter who the pastor says gives Christians liberty, **because he signed a document stating that no liberties can be taken within the church unless approved by state-granted privileges**. The screams of violation to the Gospel are already deafening, and we have barely started looking into the depths of 501c3 status.”*

In addition, a point which the writer of this article did not cover is this fact. Just like it was never God's will that divorce be allowed, the same principle applies to His church **not** paying their taxes! As Christians, God and His Word are supposed to be our supreme authority.

Moreover, many churches and grassroots organizations feel they should be tax exempt and have applied to be because it is currently allowable by law. Can you imagine if every taxpaying American citizen was exempt from paying their taxes? How would the government have sufficient revenue to do what they **need** to do? And, other than printing more “monopoly money” how would they increase their revenue? The answer is—as we are now witnessing—they would simply pass on their need to increase revenue to those who **do** pay their taxes to make up for those who don't! Also, worth mentioning is this. Some Pastors and ministry people I know felt led to apply for their tax exempt status because it is allowed by law so they are taking advantage of what is legally permissible. But as you know there are always “strings” attached and nothing is for free.

However, the Lord told me I was not to apply for tax exempt status, so I have not and will not do so. Furthermore, He confirmed it with all these scriptures I am sharing with you now.

Therefore, let’s see what God’s Word has to say about **His** people paying their taxes. In the following scripture the Apostle Paul is talking to believers, not the lost, in Romans 13:1-7 below. Notice in Romans 13:1-5 below we are told that if we have rulers who are unleashing and bringing terror on their subjects, which by the way we are witnessing and experiencing, it is because God is using them as an avenger to execute wrath on those who practice evil! Then in Romans 13:6-7 we are told specifically because all those in authority are appointed by God—they are God’s ministers, it is for this reason we are to pay taxes.

“Let every soul be subject to the governing authorities. For there is no authority except from God, and the authorities that exist are appointed by God. Therefore whoever resists the authority resists the ordinance of God, and those who resist will bring judgment on themselves. For rulers are not a terror to good works, but to evil. Do you want to be unafraid of the authority? Do what is good, and you will have praise from the same. For he is God’s minister to you for good. But if you do evil, be afraid; for he does not bear the sword in vain; for he is God’s minister, an avenger to execute wrath on him who practices evil. Therefore you must be subject, not only because of wrath but also for conscience’ sake.” ~ Romans 13:1-5 (NKJV)

“For because of this you also pay taxes, for they are God’s ministers attending continually to this very thing. Render therefore to all their due: taxes to whom taxes are due, customs to whom customs, fear to whom fear, honor to whom honor.” ~ Romans 13:6-7 (NKJV)

Then in Luke 20:19-25 below, Jesus is reiterating we must pay the government the taxes due and we must give to God our tithes and offerings. We are to do both. Jesus didn’t say to His people to just pay our tithes and offerings and forget about supporting those in authority by **not** paying our taxes! God’s leaders are called to be the “change” we want to see in the world for His glory and His purpose to prevail and we are expected to set the example for our flocks to follow based on the Word of God.

“And the chief priests and the scribes that very hour sought to lay hands on Him, but they feared the people—for they knew He had spoken this parable against them. So they watched Him, and sent spies who pretended to be righteous, that they might seize on His words, in order to deliver Him to the power and the authority of the governor. Then they asked Him, saying, “Teacher, we know that You say and teach rightly, and You do not show personal favoritism, but teach the way of God in truth: Is it lawful for us to pay taxes to Caesar or not?” But He perceived their craftiness, and said to them, “Why do you test Me?” Show Me a denarius. Whose image and inscription does it have?” They answered and said, “Caesar’s.” And He said to them, “Render therefore to Caesar the things that are Caesar’s, and to God the things that are God’s.” ~ Luke 20:19-25 (NKJV)

Furthermore, the best example found in God’s Word about **His** people paying their taxes is in Matthew 17:24-27 below where Jesus paid the **temple** tax, even though He was being taxed to enter His own house (the temple)

on the earth for goodness sakes! Jesus was willing to pay the temple tax, to get into His own house, as an example for all of us to follow which is this. Sometimes we must engage in otherwise unprofitable pursuits for the sake of upholding our witness as citizens of the kingdom of God because we are not children of this world, or the kings of this world, rather we are children of God! Jesus did not assert His right to be exempt from paying taxes that His Word tells us to pay!

*“After Jesus and his disciples arrived in Capernaum, the collectors of the two-drachma **temple tax** came to Peter and asked, “Doesn’t your teacher pay the **temple tax**?” “Yes, he does,” he replied. When Peter came into the house, Jesus was the first to speak. “What do you think, Simon?” he asked. “From whom do the kings of the earth collect duty and taxes—from **their own children** or from others?” “**FROM OTHERS**,” Peter answered. “Then the children are exempt,” Jesus said to him. “But so that we may not cause offense, go to the lake and throw out your line. Take the first fish you catch; open its mouth and you will find a four-drachma coin. Take it and give it to them (the kings of the earth) for my tax and yours.” ~ Matthew 17:24-27 (NIV)*

In addition, do **not** miss the significance of what Jesus is saying! He is saying that the children of the **kings of the earth** will **be exempt** from paying their taxes! And as we are witnessing now, they are the same ones who are being exempted from Obamacare too! More importantly, based on Matthew 17:24-27 above, by Jesus’ actions He is driving home the point that He is the Son of God, and Peter is a child of God, and as such, they will pay their taxes! In other words, they are not children of the kings of the earth, therefore, they are **not** exempt from paying their taxes! And, even though more than anyone else, they should have the right to not have to pay the **temple** tax, because the temple belongs to God and His children, not the kings of the earth, they will pay the temple tax. Why? Because this is what **their** heavenly Father, not the kings of the earth, says to do in Romans 13:6-7! And, as such they will listen, “do” and be accountable only to God and His Word!

Therefore, for those churches and ministries who have accepted the terms and conditions of being tax exempt, because they applied for the letter from the IRS, they are beholden to the “state” rather than God, in order to keep their tax exempt status. And as such, they are “legally” obligated to abide by their rules if they want to keep their “letter” from the IRS substantiating their 501c3 status! In ignorance many churches have abdicated their right to do what God requires by signing a legally binding contract giving the “state” the right to meddle in their affairs! The Lord wants us to be accountable only to those laws which do **not** go against Him and His Word!

In addition, according to Liberty Counsel, “The fundamental difference between churches and every other non-profit organization is that all non-profit organizations, except churches, must apply to the IRS to get tax-exempt approval. The IRS letter will acknowledge that the organization is tax-exempt and contributions to that group are tax deductible. Churches are completely different. In the IRS code they are exempted from the application process. From the moment of conception, if you will, a church is automatically exempt without applying to the IRS.”

Therefore for those churches and ministries, who have applied to the IRS for a letter to get tax-exempt approval, they are bound to the terms and conditions thereof.

As Christians Yahweh, our heavenly Father, and His Son, Jesus Christ, is our King and our allegiance must belong to Him alone by honoring His precepts, principles, and commandments found in His Word! Therefore, for those who have accepted the terms and conditions of their tax exempt status by applying for a letter from the IRS, there will come a point in time they will need to draw that line in the sand as to whom they will ultimately pledge their allegiance.

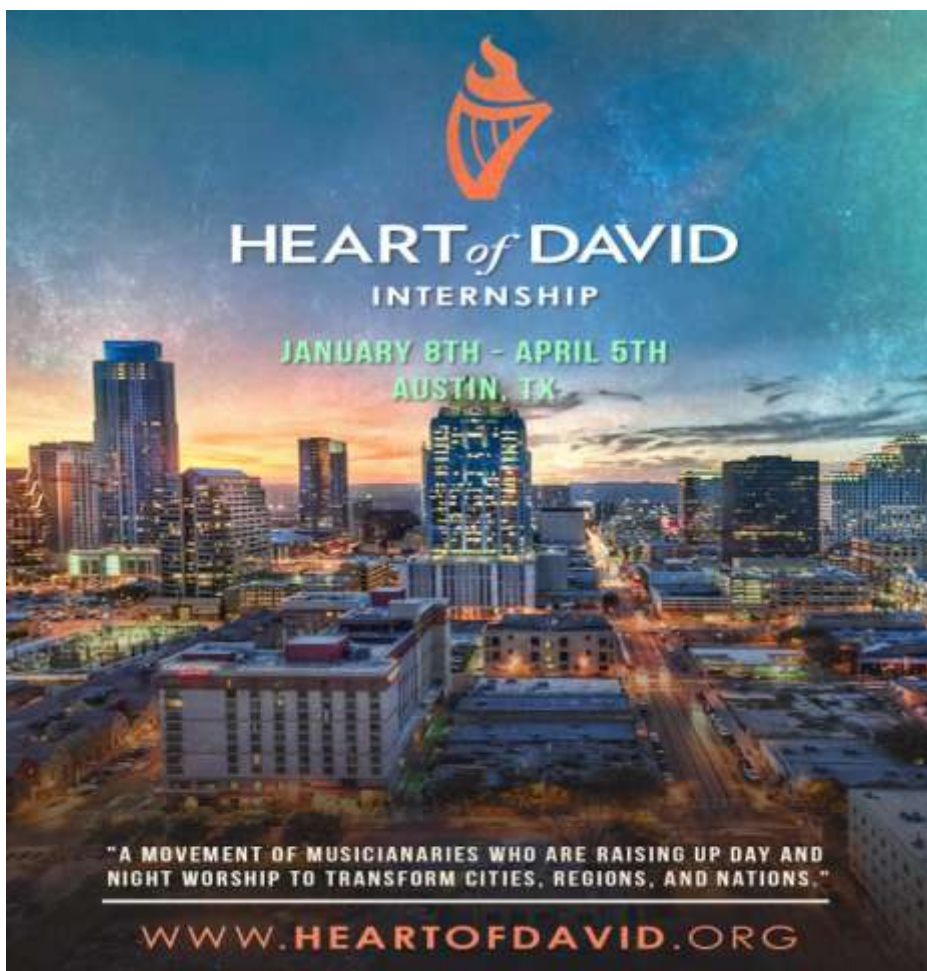
FYI Item #12:

For what it is worth—contact Bill Nelson to vote no on the Employment Non-Discrimination Act (ENDA)

Several days ago, Senator Bill Nelson (D-FL) signed on as a co-sponsor of the Employment Non-Discrimination Act (ENDA), moving the legislation one step closer to passage in the Senate. ENDA is the federal bill that would prohibit discrimination based on sexual orientation or gender identity against employees by employers with 15 or more employees.

Prior to his announcement, Nelson had been one of only three democratic senators, along with Joe Manchin (WV) and Mark Pryor (AR), who had not signed on as co-sponsors of the legislation.

"We are proud to see Senator Nelson standing on the right side of history and standing up for the values of equality and fairness," said Nadine Smith, CEO of Equality Florida "He is a leader who listens to the facts and has also listened to his heart."

In a series of meetings with Senator Nelson, he heard firsthand the stories of the harm inflicted on due to discrimination. His sponsorship... matters, as others in the Senate, including Republicans, look to his leadership on issues," added Smith. "Special thanks go to Michael Emanuel Rajner, Legislative Director for the Florida GLBT Democratic Caucus, who worked tirelessly to help move Senator Nelson from quietly sending signals that he would vote for this bill, to cosponsoring it."

In addition to face-to-face meetings with Sen. Nelson, Equality Florida recently mobilized supporters in a Twitterbomb and Thunderclap campaign asking the senator to co-sponsor ENDA.
