This following came in from Cindy Jacobs, via the US Reformation Prayer Network. For the first time in American history, the United States Supreme Court will decide on the continuity of public prayer. Please read the alert below, and do your part to pray and act!

This is a crucial time in American history - public prayer is in jeopardy. WallBuilders has worked with **Alliance Defending Freedom** in the past and stood with them as they fought for our religious freedom. As such, we wanted to make you aware of a case they are trying at the U.S. Supreme Court - *Town of Greece v. Galloway*.

For the first time in 400 years, the United States Supreme Court will decide whether or not public prayer will be allowed to continue. November 6th will be a crucial day in America's history as this case is heard before the Court. Three days later, the Supreme Court will make a decision, but it will not be announced until months later. We ask you to stand against this threat with prayer and fasting, especially November 6-9, as the Court hears this case and comes to a decision.

Asking God's blessing on public meetings is a cherished American tradition that is now in jeopardy. This

practice is at risk because of a challenge brought by two citizens from Greece, New York, who claims to be “offended” by prayers given to open their city’s council meetings.

For years, the Greece Town Council has allowed *volunteers* from the community to begin its meetings with an invocation. But rather than respect the volunteers’ heartfelt prayers for divine guidance, the two “offended” citizens and Americans United for Separation of Church and State filed a lawsuit to end this cherished practice.

Alliance Defending Freedom and lead counsel Thomas G. Hungar will go before the U.S. Supreme Court November 6 to defend the Town of Greece – and all Americans who want to pray in a manner consistent with their faith – in order to preserve public prayer in America.

TITLE: ONGOING WORK IN STATE LEGISLATURES - 2 TO 3 YEARS FOR RATIFICATION OF “SOVEREIGNTY AND STATES RIGHTS AMENDMENT

Sovereignty and States rights amendment convention is going forward quickly and reactions from citizens and legislators have been extremely positive.

When 34 State Legislatures complete similar “Applications” under Article V directing Congress to convene the “Sovereignty and States Rights Amendment”, Congress is obligated to convene the called for Convention.

The *Delegate Resolution* defines the duties and obligations of the delegates the Legislature sends to the Convention. The delegates are Ambassadors representing their State Legislature at the Convention. They are not free Agents. The *Delegate Resolution* incorporates the pre-approved text for the proposed Amendment.

Encroachment by the Federal Government has been prohibiting States from exercising their Tenth Amendment Rights. The “Sovereignty and States Rights Amendment” will restore these Rights by:

1. Restoring and protecting the Sovereignty of the United States Constitution.
2. Restoring and protecting the Sovereignty of State Legislatures and State Constitutions by prohibiting the encroachment of these rights by the Federal Government through Countermand Authority.
3. Providing *Enforcement Powers* under State Laws when the Federal Government refuses to prosecute violators of the provisions of the Article.
4. Assure that the Federal Government does not violate Citizens’ rights to be secure in their persons when the Government uses electronic or other methods of surveillance.

When the “Sovereignty and States Rights Amendment” is ratified, the States will have the authority to Countermand (both current and retroactive) laws, legislation, regulatory rulings and Supreme Court decisions that are onerous to the States. When 30 States present their Countermands the law in question (e.g. Obamacare, Common Core, Roe v. Wade, etc.) is automatically repealed or disallowed. The greater benefit of this Amendment is the Federal Government can still function, but before Congress or the Courts create new laws, they will be far more amenable to State interests.

rules it passes for the people."

[Senator Rand Paul agrees](#). Just this week he introduced S.J. Res. 25 "proposing an amendment to the Constitution of the United States relative to applying laws equally to the citizens of the United States and the Federal Government." See below.

This said, we need to tell every lawmaker to join in with Desantis, Salmon, and Paul and run with the idea of a Constitutional amendment to subject government to its own laws!

### **It's Natural**

It's only natural that the government should live under its own laws - such is the American Way.

Our founders based the Constitution upon natural law or "the law of Nature and Nature's God." Natural law says that there is one law to govern all, not one law for the People and a separate law for those in government.

Is this not still true today?



**SUBJECT: Request for Investigation into Possible Official Misconduct by Florida Elected and Appointed Officials on the Matter of Manmade Climate Change.**

Dear Attorney General Bondi,

Good morning.

We the undersigned, including a leading climate science research organization and citizens groups in Florida, ask that your office immediately launch an investigation into the possibility of widespread official misconduct potentially involving fraudulent activity and malfeasance, by elected and appointed officials. While our concerns are primarily involved with SE Florida, the results of such an investigation may affect all Floridians, with likely national ramifications.

At the heart of our allegations is what appears to be a long term conspiracy by numerous SE Florida officials and their science advisors in their use of fraudulent, unreliable, manipulated data, and untrustworthy climate science reports, primarily from the United Nations Intergovernmental Panel on Climate Change (UN-IPCC) and similar unreliable climate reports from agencies within the US government. Armed with this bad science, these officials have attempted to force unneeded and unwanted laws, regulations, planning policies, and local ordinances upon Florida citizens.

This misconduct and flawed governance uses the tool and myth of manmade climate change and the alleged adverse climate impact of mankind's greenhouse gases, primarily CO<sub>2</sub>, as a deceptive tool to create these bad policies, laws, regulations and local ordinances.

This likely misconduct by Florida officials also includes potentially deceptive science advice and collusion from taxpayer funded climate science advisors, many of whom hold teaching positions in Florida universities. In total, this bad governance based on bad science may cause permanent injury to Floridians and Florida businesses, causing severe, unnecessary, restrictions on citizens' lifestyles and the ability to operate thriving businesses here in Florida.

Additionally, should you agree to launch an independent and credible investigation of these matters, we believe misconduct by Florida officials may be found that is likely actionable. Some of the elements of official misconduct that we believe you may find could possibly include:

**Property rights restrictions using unsupportable manmade climate change justification.**

This point may involve seizure of land, homes, or restrictions of use of private property using manmade climate change and attempts to mitigate supposed greenhouse gas effects as justification.

**Potential for Unconstitutional Practices.**

Possibly illegal and/or unconstitutional attempts to bypass local, duly elected officials at the city and county level have been observed. We believe there are quasi-governmental 'regional organizations' in the State of Florida exemplified by the Seven50 Plan, as a means of imposing self-described "fascism" style controls over local communities. We believe this particular group, using the bad science of manmade climate change as a lever to enact unconstitutional regional management, may be repeated by other groups using different names in

other areas of Florida. As part of the reasons given for the creation of the Seven50 or similar organizations, is the contention that manmade climate change is forcing them to change our way of life in Florida.

**Increased, unjustifiable utility costs for individuals and businesses caused by unsubstantiated threats from manmade climate change and global warming.**

There exists a well-known history of increased energy costs throughout Florida as a direct or indirect result of the fraudulent or misleading manmade climate science and/or climate reports of the UN-IPCC and the US government.

**Fraud, waste, and abuse through unneeded and unwanted ‘sustainable’ or manmade climate change projects in energy, renewable energy, carbon sequestration and CO2 mitigation construction.**

Floridians have been subjected for many years to unneeded and unjustifiable laws and regulations that originated with the Agenda 21 plan from the United Nations as later adopted as the “Sustainable America” plans imposed on all US government agencies during the administration of President Bill Clinton. These plans have as a scientific basis, the now disproved and unreliable greenhouse gas theory. All sustainable development plans in the state may therefore rightly be considered as potential sources of fraud, waste, or abuse.

**Fraudulent Use of Taxpayer Funds on Unnecessary Construction Projects.**

Substantial mismanagement or fraudulent use of taxpayer funds may exist through the imposition of, or planning for, highly suspect construction projects based on the supposed threat of global sea level rise. These kinds of climate mitigation projects according to some estimates, may result in billions of dollars being spent on sea walls, barriers or other questionable concepts like relocation of power generation facilities, homes and communities using the fraudulent, unreliable estimates of sea level rise derived from the myth of manmade global warming and unreliable science found in the UN-IPCC and similar US government climate science/reports. The extent of construction/engineering company involvement in this suspected fraud is unknown at this time but should also be investigated.

**Conspiracy to Commit Fraud.**

We believe that according to available science, there is reason to suspect Florida officials and their climate science advisors have conspired to commit fraud against the State of Florida and their local citizens through the use of highly unreliable UN-IPCC global climate models and associated unreliable sea level rise forecasts to impose stringent, unnecessary, and likely falsely justified regulations, laws and local ordinances and other controls over Floridians. We believe that there is a possibility that Florida officials and their advisors have created a non-existent or as a minimum, a highly exaggerated threat of global sea level rise to justify this suspected fraud. We suspect they have knowingly acted in this fraudulent manner since some are well aware, or should be, that the global climate models and resultant sea level rise forecasts from the UN-IPCC and the US government have been shown to be unreliable for use by policymakers.

**Failure to use the “best available science” for governance where required by Florida laws, regulations and local governing bodies.**

In fact, according to public statements of numerous climate science experts, we believe Floridians have been subjected to what may prove to be the “worst available science,” when it comes to manmade climate change and use thereof in creating Florida laws, regulations and local governing policies and ordinances. Florida officials and climate advisory groups have routinely refused to seriously consider climate prediction science and theories that have been shown to be far more accurate than the greenhouse gas model. They have instead intentionally decided to use not the “best” but rather what is likely some of the “worst” available science for decision making, in clear violation of some existing Florida laws, regulations, or policies.

There now exists a substantial amount of evidence and publicly available information that gives us serious concern and reason to believe that UN climate reports and some of those from the US government shows the widespread presence of fraud, data manipulation, data cover-up, incompetence, or outright misconduct of authors and scientists associated with these climate reports that use the greenhouse gas theory of climate change. The long range global temperature increases and sea level rise predictions from the UN-IPCC and some agencies within the US federal government that rely on the UN-IPCC climate science, have been called unreliable and overstated by numerous climate science experts.

This failure by Florida officials to use the “best available science” extends beyond the areas noted above. For example, a review of the planned science modules for Common Core educational standards shows that the same flawed UN-IPCC climate science is going to be taught. Certain elements of this same bad science of manmade climate change may already be used in instruction at many Florida institutions from primary to university level.

Accordingly, we believe a separate investigation into the use of this bad science in Florida’s education systems should be undertaken.

### **Potential Violation of Florida “Sunshine Laws.”**

While we have no direct evidence of such, we believe that it is highly likely that elected or appointed officials have intentionally violated Florida ‘sunshine laws’ by failure to act on advice they were given that UN-IPCC and similar US government climate reports, climate models, temperature and sea level predictions, were seriously flawed and unreliable. We therefore believe it is highly likely that these officials did not disclose this critical climate information during authorized meetings, public and/or private. In so doing we believe they may have violated Florida ‘sunshine laws’ and failed in their fiduciary responsibilities.

In addition to the launch of a wide ranging and important investigation of official misconduct, we also ask that your office take whatever action is possible to immediately halt all State of Florida activities that use manmade climate change and the greenhouse gas theory as the primary cause of climate change as alleged by the UN-IPCC or similar US government climate reports.

Finally, should you accept our request and initiate such an investigation, we request that it have the highest level of independence, trust and credibility that is possible. That means in part, that members or advisors for your investigation should not come from Florida environmental or climate governing bodies and either past or current Florida environmental or climate science organizations, or their appointed members, or their science advisors, or any Florida university receiving US government (i.e. manmade climate change) funded research grants for climate science or those who provided climate advice or advisors to Florida governing bodies. We believe this measure is absolutely essential to making sure your investigation’s findings, conclusions, and recommendations are free from bias and potential conflicts. This holds especially for those organizations and individuals who may later become defendants in any resultant litigation.

If required, we would be willing to supply a list of independent conflict-free, national and international climate science experts who would add greatly to the investigation’s credibility.

We look forward to your prompt response to our request.
